2. STUDY SESSION ITEMS

**19-336 Review of Town Hall Remodel of Front Entry and Consideration of
Donated Ed Mell Sculpture to Honor Donors to Paradise Valley
Mountain Preservation Trust**

Town Manager Jill Keimach explained that one of the goals of the newly renamed Paradise Valley Mountain Preserve Trust was to recognize past donors and raise awareness about mountain preservation. In consequence, the Trust worked with local artist Ed Mell to design a large sculpture of a mountain affixed to a base listing the names of donors to the Trust. She presented three options near the entry to Town Hall for the sculpture's location. There was Council consensus favoring "Layout B" which was to the left and perpendicular to the Town Hall entrance. It would require

removing a bike rack and designing a drainage solution. Council made the following requests:

- Prepare design plans and renderings for Council review
- Review drainage
- Limit lighting to something discrete
- Police assessment of the location and dimensions of the sculpture both as a vehicular barrier and for the potential of blocked views
- Consider a shade structure and hardscape at the entrance to Town Hall for people to congregate during community events

19-315 Discussion of Lavitt Manor II Final Plat, a Two Lot Subdivision with Private Road, Located at 7525 North Ironwood Drive

Planner George Burton presented a final plat for a two-lot subdivision with a private road located at 7525 N Ironwood Dr. The Planning Commission reviewed and approved the preliminary plat and private road conditional use permit on August 20, 2019 by a vote of 7 – 0. He stated that the final plat is in substantial conformance with the preliminary plat. He summarized the final plat and noted public comments that were received at the Planning Commission hearing and those received since then.

The Council discussed the plat and posed questions regarding infrastructure capacity and future improvements. There was consensus to schedule the final plat for a vote on September 26 at which time the Council asked for staff to provide a more detailed response to the concerns raised by residents who submitted comments.

19-329 Discussion of Amendment to the Town's Investment Policy

Chief Financial Officer Douglas Allen presented a recommended change to the Town's Investment Policy that would provide greater flexibility in the distribution of investments among the Town's outside broker PFM, Wells Fargo, and the Local Government Investment Pool (LGIP). He recommended increasing the maximum investment limit in LGIP from \$7.5 million to \$10.5 million. The investment limit has not been amended since 2007. This amendment would allow the Town to maximize interest income based on which funds are performing better. He stated that a complete review of the Town's investment policy was scheduled for a future date and would include representatives from PFM, Wells Fargo, and the Town's financial auditing firm.

There was Council consensus to schedule the amendment for a vote on September 26; however, Council asked for further justification for establishing a dollar amount limit instead of a percentage allocation.

Council Member Pace moved to go into executive session at 4:45 PM to discuss items 19-326 and 19-318. Council Member Dembow seconded the motion which passed by the following vote:
