General Notes

This public meeting was conducted in an open house format with the roll plots and renderings present. There was a headcount of about 13 residents in attendance. After residents were able to look at the materials, a PowerPoint presentation of the overall project limits, anticipated costs, and schedule was conducted to a public audience of 14 persons.

In general, the residents were in favor the drainage improvements, but some residents voiced concerns with the chicanes, landscaping, and pedestrian mobility along the roadway. One resident requested the plans to see how the impacts of the Merrill Cantatierra storm drain outfall will be impacted.

Some residents questioned whether speeding was really an issue for this corridor. The project team described how the speed study shows there are speeds in excessive of 60 MPH with the posted speed of 35MPH. A resident asked if the posted speed would change from what it is currently. The posted speed of 35MPH is not proposed to be changed with this design. One resident requested that the project management team please send him the most recent speed study of the corridor that was completed.

Residents suggested that stop signs or speed cameras be considered to mitigate speeding. The project team discussed how stop signs must be warranted, and they cannot directly be used as a traffic calming measure. In this case, the stop signs are not warranted to be installed. The Town's Mayor discussed that

the speed cameras each year are in threat of being banned by the State legislature and how the Town does not see speed cameras as a viable long-term solution.

Residents were concerned with the cost of the improvements and if the chicanes would really work to reduce speeding. The project team discussed how national engineering traffic studies show that chicanes and narrower roadway lane widths are an effective measure to reduce speeding. Based on the comment cards (attached), a few residents recognize the speeding concerns for this corridor and want to see the traffic calming improvements.

Residents raised a concern that there would be a safety issue between cyclists and vehicular traffic at the beginning and ending points of the chicanes/gore areas. The project team discussed how the cyclists will be separated from the motorists in more locations due to the chicanes. There are bike buffers included in the roadway design in certain areas, and the roadway horizontal curves have been designed per engineering standards (AASHTO Green Book) for safety.

Residents voiced concerns with the amount of vegetation that will be provided in these chicanes and medians and how it can be difficult to see past or through the vegetation when entering Mockingbird Ln. The project team discussed how all the plantings would be strategically placed to mitigate the sight visibility concerns, and how the landscape will be maintained/irrgiated. The design will follow the Town's standard guidelines for sight visibility.

Upon review of the sign-in sheets and project feedback to date, there was very little overlap in participants from this public meeting from the one that was held in November 2022.


