8 **ORDINANCE NUMBER 2017-03**

10 **AN ORDINANCE OF THE TOWN OF PARADISE VALLEY,**
11 **ARIZONA, AMENDING ARTICLE 8-3, SANITATION;**
12 **SECTIONS 8-3-6, VEHICLE REQUIREMENTS**
13

14 **BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF**
15 **PARADISE VALLEY, ARIZONA:**
16

17 Section 1. The Town of Paradise Valley's Code is hereby amended as follows,
18 showing text to be added in **bold** and deleting the text shown by ~~strikeout~~.

20 Section 8-3-6 VEHICLE REQUIREMENTS:
21

22 A. All vehicles used for refuse collection within the Town must be inspected and provide
23 certification that they meet the following minimum requirements:
24

- 25 (1) Vehicles must be in good condition and repair. The bodies shall be of readily
26 cleanable construction, watertight and metal-lined to the full width and height
27 of the body, with all seams welded.
28 (2) Vehicles shall be maintained and operated in a clean and neat manner so as to
29 prevent refuse from spilling, leaking and blowing. All vehicles shall have
30 enclosed bodies. Where spillage does occur, it shall be picked up immediately
31 by the collector and returned to the vehicle or container.
32 (3) The outside of each vehicle must be clearly identified by the name and
33 telephone number of the contractor operating the vehicle.
34 (4) Any open-top roll off container must have a cover that prevents refuse or
35 contents from spilling or flowing onto the roadway.
36 ~~(5) Starting on July 1, 2017, all vehicles with diesel engines shall be no older than~~
37 ~~seven (7) years.~~

39 ~~(6)~~ (5) Vehicle fleet is required to have "operation-at-idle" and "smart back up"
40 technology.
41

42 B. Unless there is a specific need for other types of collection equipment, all residential
43 solid waste and recyclable collection vehicles shall be of the automated side loading
44 design, intended to service 60 to 100 gallon wheeled containers. All licensees shall
45 provide containers that are free of noticeable defects and in good working order,
46 including a lid that prevents rainwater from entering the container and a fully
47 functioning hinge.

48 Section 2. If any section, subsection, sentence, clause, phrase or portion of this ordinance
49 or any part of these amendments to the Town Code adopted herein by reference is for any

1 reason held to be invalid or unconstitutional by the decision of any court of competent
2 jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

3 Section 3. This ordinance shall become effective in conformance with Arizona law.
