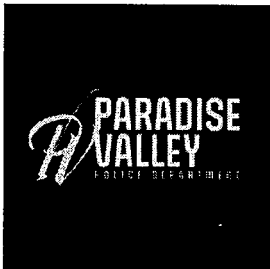
Good afternoon Paul,



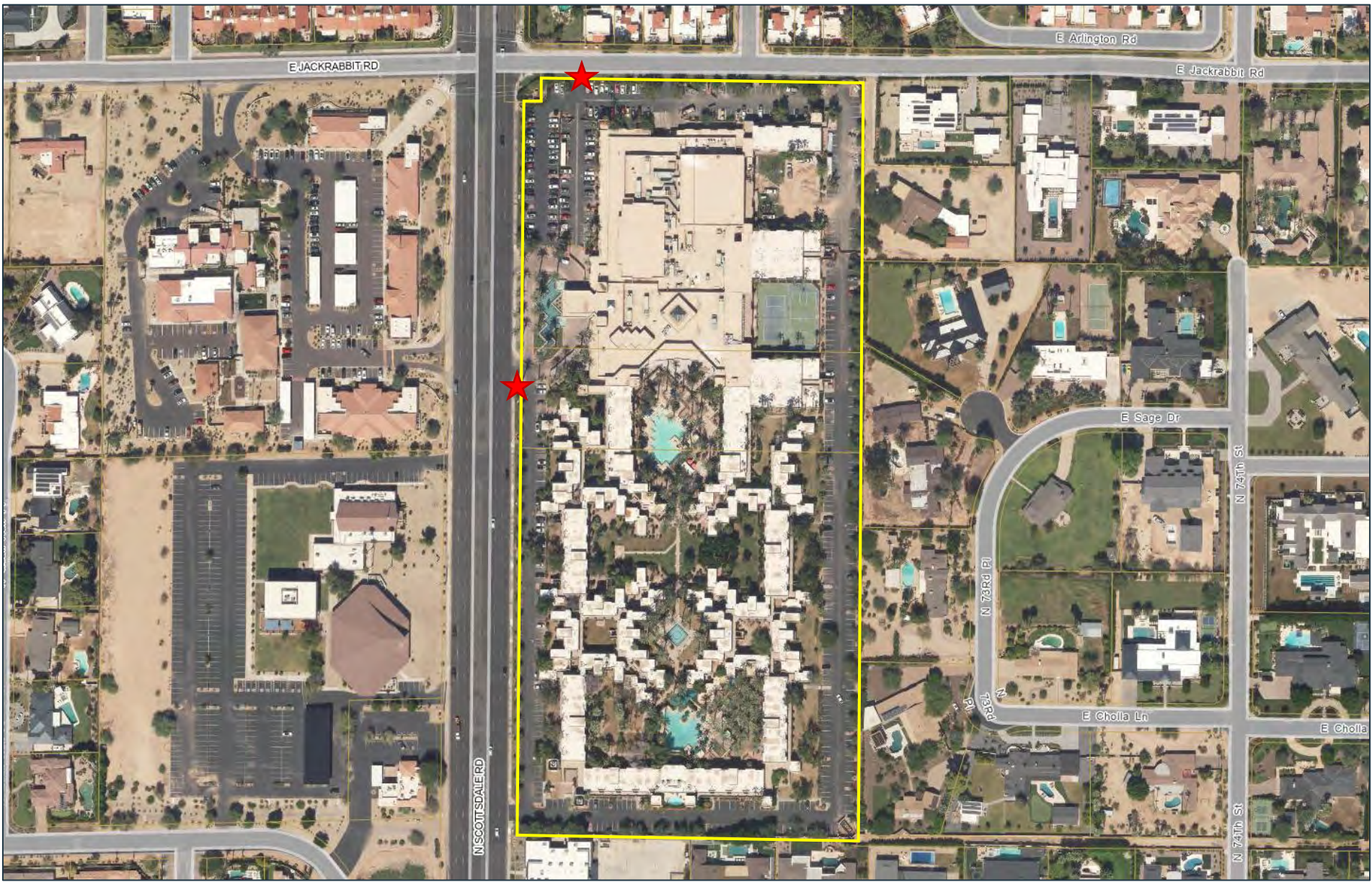
