Mike Surguine thanked everyone for joining us for the meeting and introduced Ryc Loope of HL Design Build who gave a thorough power point presentation with slides of the planned Interstitial Plan for 43 new guest rooms throughout the property; additional parking spaces; a new family pool with snack bar and restrooms; expansion of the Views ballroom with additional storage and staff offices, and additional patio space.

With the expansion of the Views the north side of the patio will be enclosed and the north wall will be all windows. The roofline will stay the same at the maximum height of 24 feet. The west side of the building will become a patio area facing west. We need to reduce parking on Superstition Lane for vendors servicing the Views ballroom.

Questions:

What is demand of resort occupancy?

MSurguine - In March and April the resort is sold out half the time and 90% all the time.

SLyon - The spa and restaurant can accommodate the increase as 75% use of the restaurant is by locals and members.

Water – is the water sufficient to supply new casitas?

RLoope - Yes

Will parking be sufficient with new casitas?

RLoope – Additional parking spaces will be added where right turn to casa road will be changed and other spaces throughout the casitas. There will be a total of 20-24 spaces added.

What is size of new casitas?

On average they are smaller than the current casitas. Half of our existing rooms are suites at 1,000sf. The new casitas will be 550sf to 800sf and the Bungalows will be 400sf.

Neighbor – asked what neighbors can do to show their support of the project.

RLoope – Mentioned they could attend the upcoming Town Meetings to speak and show their support or they could call the Town offices to voice their support. Ryc Loope mentioned the Town meetings are open to the public and the support of the neighbors is most appreciated.

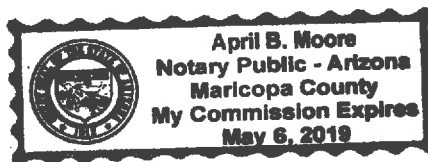
