34 Building Code 2015; International Residential Code 2015; International Mechanical Code  
35 2015; International Plumbing Code 2015; International Property Maintenance Code 2015;  
36 International Fuel Gas Code 2015; International Energy Conservation Code 201, National  
37 Electrical Code 2014 and International Fire Code 2015 updating the Town Code.

39 **Section 3.** The above referenced documents are hereby declared to be public records  
40 within the meaning of A.R.S. §9-802, and three (3) copies thereof shall be kept on file in the  
41 office of the Town Clerk and available for public use and inspection during normal business  
42 hours.
