9 **A RESOLUTION OF THE MAYOR AND COUNCIL OF**  
10 **THE TOWN OF PARADISE VALLEY, ARIZONA**  
11 **ACCEPTING AND ADOPTING THE VISUALLY**  
12 **SIGNIFICANT CORRIDORS MASTER PLAN**

13  
14 WHEREAS, in October, 2016 the Paradise Valley Town Council (“Town  
15 Council”) retained Environmental Planning Group and Michael Baker International, to  
16 work with the community and Town of Paradise Valley (the “Town”) on a master plan  
17 for visually significant corridors (the “Visually Significant Corridors Master Plan”);  
18 and

19 WHEREAS, the 2012 General Plan for the Town of Paradise Valley was adopted  
20 by the Paradise Valley Town Council (“Town Council”) by Resolution 1243 on  
21 November 10, 2011 and was ratified by the Paradise Valley voters on March 13, 2012;  
22 and

23 WHEREAS, the Visually Significant Corridors Master Plan is a master plan for  
24 visually significant corridors and fulfills one of the Town Council’s Quality of Life  
25 Initiatives and an implementation measure that was part of the 2012 General Plan; and

26 WHEREAS, on June 19, 2018 the Paradise Valley Planning Commission held a  
27 public hearing, and voted 7 to 0 to forward the Visually Significant Corridors Master  
28 Plan to the Town Council with a recommendation that it be adopted as a master plan;  
29 and

30 WHEREAS, the Town Council has reviewed and received public comment on

1 the Visually Significant Corridors Master Plan; and believes the adoption of this plan  
2 is in the best interest of the Town.

3 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND**  
4 **COUNCIL OF THE TOWN OF PARADISE VALLEY, ARIZONA AS**  
5 **FOLLOWS:**

6 SECTION 1. The Town Council hereby: accepts the Visually Significant  
7 Corridors Master Plan attached as Exhibit “A” hereto and incorporated herein by this  
8 reference.

9 SECTION 2. The Town Council directs Town staff to engage in the activities  
10 aimed at implementing the Visually Significant Corridors Master Plan.

11 SECTION 3. The Town hereby declares that the entire Visually Significant  
12 Corridors Master Plan is a supplement to the 2012 General Plan.

13 SECTION 4. Effective Date. This Resolution shall take effect immediately  
14 upon adoption.
