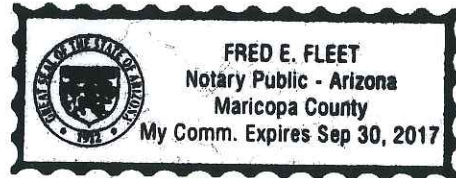

For this to happen, the owner must complete three applications: (1) Re-plat of the September 2015 Final Plat, (2) a Preliminary Condominium Plat Map, and (3) a Final Condominium Plat Map.

The Final Plat of "The Villas at Mountain Shadows II" was approved on November 19, 2015. This approval consisted of eight villa home lots as part of the Mountain Shadows Resort Special Use Permit. The owner requests to develop seven villa home lots, instead of the eight villa home lots. For this to happen, the owner must complete a Re-plat of the November 19, 2015 Final Plat.

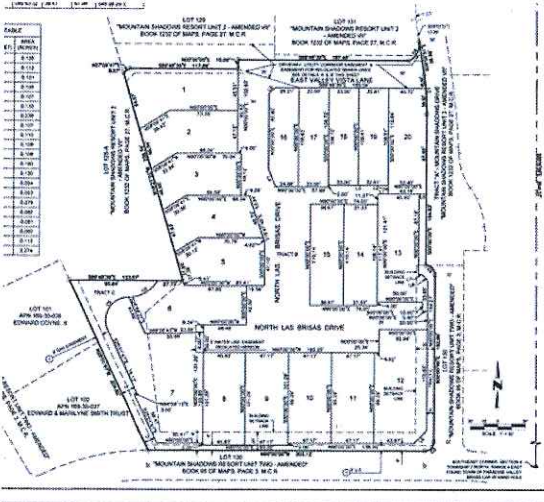

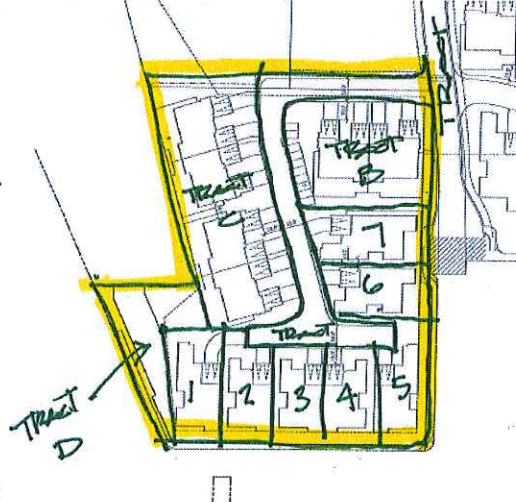

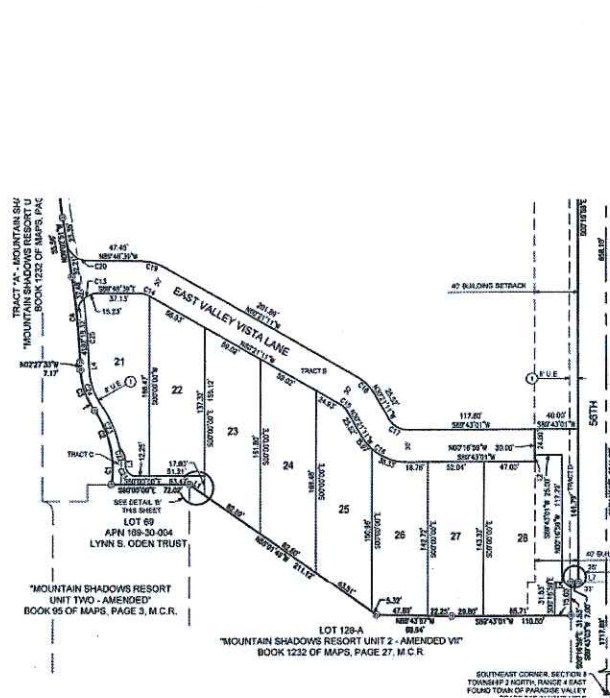
**A. APPROVED SEPT 2015 PLAT EXCERPT**



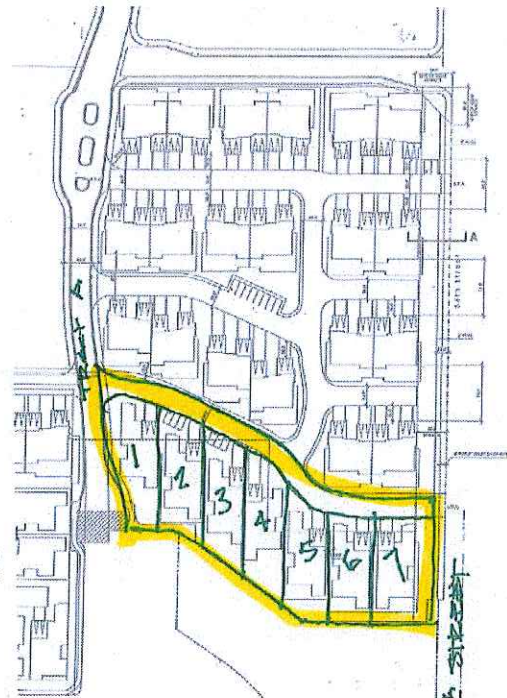
**PROPOSED RE-PLAT ILLUSTRATION**

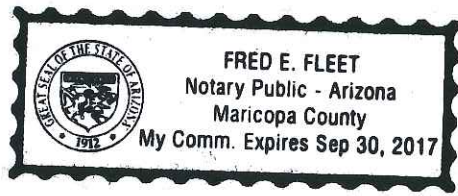

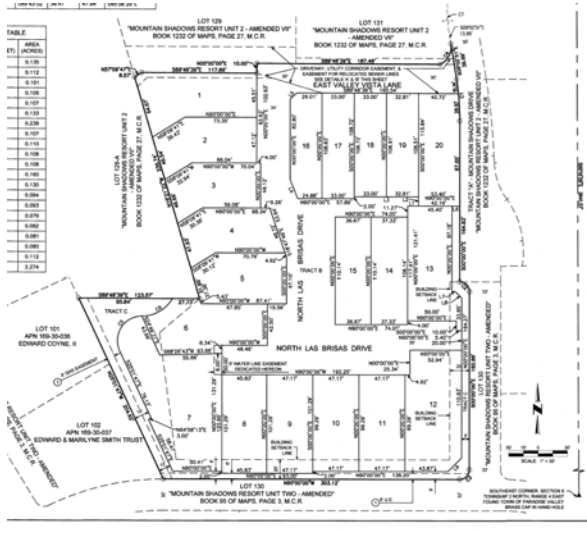

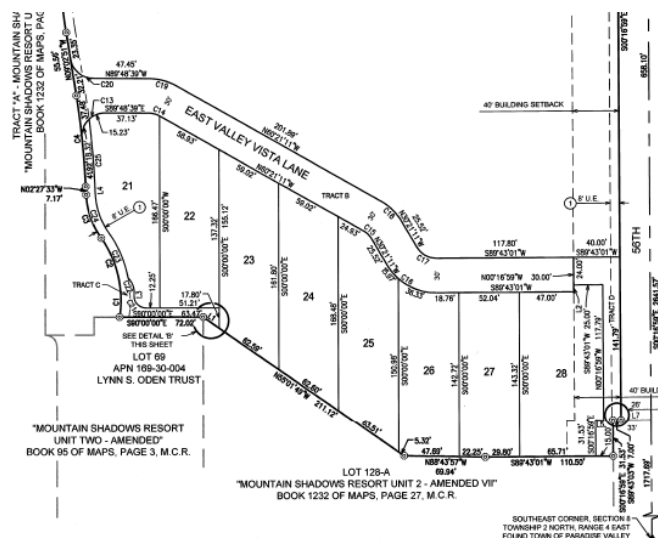
