2<sup>nd</sup> Resident who lives on Smoketree Lane (did not specify address): Comments on location due to proximity to APS transformers makes a lot of sense to her as she had solar put on her house and the trenching all over the property and across drives and walkways was very disturbing, so she thinks it makes good sense to mitigate these issues by keeping the panels close to transformers.

RSA requested and received a copy of the presentation materials, which Charles Brown did email her after the meeting adjourned.
