3. STUDY SESSION ITEMS

26-007 Discussion on Proposed Amendments to Article XVII, Assisted Living Home, of the Zoning Ordinance

Mayor Stanton reconvened the meeting at 4:40 PM

Planning Manager Paul Michaud summarized a proposed ordinance amending Article XVII of the Zoning Ordinance related to Assisted Living Homes. The ordinance consisted of three changes:

1. Maximum occupancy would be reduced from 10 to 6 residents, not including the operator and staff and members of the operator’s family, with a maximum not to exceed eight people.
2. All parking associated with the home shall be limited to on-site only
3. Replace the department director’s title from Planning Department to Community Development Director.

Mr. Michaud noted that the proposed modifications to assisted living homes did not include changes to the existing regulations for homes for the developmentally disabled, or to sober living or other similar facilities that would fall under the Town’s reasonable accommodation process adopted in 2017 via Resolution 2017-15. Also, existing lawful assisted living homes would be allowed to continue to operate with up to 10 residents should the ordinance be adopted.

The Planning Commission held a Citizen Review Session on November 18, 2025 and voted 4 to 3 to forward the ordinance to Council with a recommendation for approval.

He stated that the ordinance is scheduled for a public hearing and Town Council action on January 22, 2026.

26-004 Discussion and Possible Action to Recognize 5404 E Palo Verde Drive as a Historic Property in the Town of Paradise Valley

Historical Advisory Committee Chair Catherine Kauffman presented the Committee's recommendation to recognize the Sleighel home located at 5404 E Palo Verde as an official historic property in the Town of Paradise Valley.

The Town Council approved the Historical Advisory Committee's recommendation by unanimous consent.

On behalf of Mayor Stanton, Council Member Liepmann read a proclamation recognizing the addition of the home to the Historic Property Program and Mayor Stanton presented owners with a bronze plaque to mount on the property.


