10	A RESOLUTION OF THE MAYOR AND COUNCIL OF
11 12	THE TOWN OF PARADISE VALLEY, ARIZONA, AUTHORIZING AND DIRECTING THE PROPERTY
13	LOCATED AT 4554 E. MCDONALD DRIVE BE
14	EXCLUDED FROM HILLSIDE AS DEFINED IN ARTICLE
15	XXII, HILLSIDE DEVELOPMENT REGULATIONS, OF
16 17	THE TOWN ZONING ORDINANCE.
18	BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWN OF
19	PARADISE VALLEY, ARIZONA THAT:
20	
21	WHEREAS, A&E Managed Investments, L.L.C ("Applicant"), property owner of
22	4554 E. McDonald Drive, Lot 3, Camelhead Vista, according to Book 78 of Maps, Page
23	23, Records of Maricopa County, Arizona, has requested that the Town of Paradise Valley
24	("Town") consider removing Lot 3 from Hillside Development Area, as such term is
25	defined in Article II of the Town Zoning Ordinance and in Article XXII, Hillside
26	Development Regulations; and
27	WHEREAS, the Hillside Building Committee, which was established pursuant to
28	Article XXII of the Town Zoning Ordinance, has after public notice and public hearing
29	recommended to the Town Council that Lot 3 be removed from the Hillside Development
30	Area; and
31	WHEREAS, the Town Council held a public meeting on April 12, 2018, in the
32	manner prescribed by law, to hear and to take action on the Applicant's request to remove
33	Lot 3 from the Hillside Development Area; and

2	WHEREAS, the Town Council finds that the Applicant has satisfactorily
3	demonstrated that Lot 3 has a building pad and site slope less than ten percent and that no
4	cause exists for retaining Lot 3 as a Hillside Development Area; and
5	WHEREAS, the Town Council finds that the removal of Lot 3 from Hillside
6	Development Area is supported by characteristics of said property such as its location
7	adjacent to a major arterial roadway, its limited prominent natural features and its slope less
8	than ten percent;
9	NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of
10	the Town of Paradise Valley, Maricopa County, Arizona, as follows:
11	SECTION I. <u>In General</u>
12	1. Lot 3 of Camelhead Vista, according to Book 78 of Maps, page 23, Records of
13	Maricopa County, Arizona is hereby removed from the Hillside Development
14	Area as such term is defined in the Town Zoning Ordinance.
15	2. The Town Manager and Town Attorney are authorized to take all actions
16	necessary, including the reprinting and revising of the Hillside Development
17	Area map shown as "Figure 2 - Hillside Development Area" in Article XXII of
18	the Zoning Ordinance so as to remove Lot 3 from those lots or areas designated
19	as a Hillside Development Area on said map.
20	

- 3. That removal of a hillside designation on a property may cause certain aspects of the structures on said property to no longer be in compliance with the Town Code as some regulations governing hillside and non-hillside properties differ, such as the measurement of building height. Being it the intent of the Applicant to remodel and add onto the home and demolish accessory structures on said property, any such nonconformity will cease to exist. As such, the Applicant shall complete one of the following within 360 days from the approval of this Resolution:
 - a. Submit to the Town, and receive all necessary approvals, for a demolition of all or part of said home and associated structures such that all structures to remain are in compliance with the code provisions in effect at the time of submittal, or
 - b. Submit for approval by the Town Community Development Director, or designee, the necessary documentation that said home and associated structures are in compliance with the Town Zoning Ordinance as it relates to a non-hillside property.

19 SECTION 2. Effective Date

20 This resolution be in full force and effect immediately upon its adoption.
