

# TOWN COUNCIL MEETING 6401 E. LINCOLN DRIVE PARADISE VALLEY, ARIZONA 85253 MINUTES Thursday, February 25, 2016

#### 1. CALL TO ORDER / ROLL CALL

#### 2. STUDY SESSION ITEMS

# 16-059 <u>Discussion of the Town's Procurement Code, Policies, and Procedures</u>

Town Manager Kevin Burke stated that when he was hired, the procurement responsibilities were decentralized with each department conducting their own purchasing processes. With the Council's permission, a contract employee was hired to

review and recommend changes to current procurement policies and centralize and standardize the process.

Director of Administration and Government Affairs Dawn Marie Buckland presented the draft changes the procurement code and administrative policies.

The Council discussion focused on the expenditure threshold amounts that would trigger specific Council approval regardless of whether the item was budgeted.

The Council requested additional information on the following:

- Specific examples for why the current managerial expenditure authority of \$25,000 should be raised to\$50,000
- Possible require a Town Manager finding to justify the \$50,000 expenditure without Council approval, (i.e. the purchase was required during the Council's summer recess.)
- Ask the Town's financial auditors if there are best practices on procurement.
- Research and recommend remedies for violation procurement code can the contract be void if the proper procurement process was not followed?
- Clarify that serial purchases with the same vendor cannot be used to violate the expenditure limits.

Mr. Burke stated that this item would be scheduled for another Study Session before it was scheduled for approval.

## 16-054 <u>Discussion of APS District 30 Underground Conversion District</u>

Public Works Director/Town Engineer James Shano and Engineering Services Analyst Jeremy Knapp reviewed the thirty year history of utility undergrounding in Paradise Valley. Mr. Knapp introduced Ron Gandara and Katie Pendergast representing APS.

Mr. Knapp stated that District 30 is the final undergrounding district in the APS service area. The district is challenging because it is located on the border with the City of Scottsdale. In fact, the "backbone service line is located in an alley in Scottsdale.

Mr. Knapp presented 3 options:

- 1. Underground only the lines in the Town
- 2. Underground the lines in the Town and the backbone
- 3. Underground the lines in the Town, the backbone, and the remnant lines in Scottsdale

He discussed the financial impacts of each option and the various cost-sharing opportunities with APS and residents in Paradise Valley and Scottsdale.

There was Council Consensus to direct staff to contact the residents in Paradise Valley and Scottsdale to gauge interest in option 2.

If 50% of all 43 lots commit to the project and contribute the aggregate total contribution necessary, the Town will proceed with the project. The Council also stated that if there is support for option 3 and the residents are willing to contribute more, the Town would consider funding the balance.

# 16-056 Discussion of Scottsdale Sewer IGA

Mr. Shano briefed the Town Council on the Town's wastewater utility infrastructure, the wastewater master plan, the current intergovernmental agreement with the City of Scottsdale approved in 1998, the proposed new intergovernmental agreement, and the financing needs for maintaining the system.

He explained that discussions regarding the proposed new IGA have been productive. He stated that the previous plan to "close they system" to more accurately measure the total amount of wastewater flows into Scottsdale's system would be unnecessary. The new IGA not only eliminate this need, but also would allow the Town to remove all 13 monitoring stations. Instead, the Town's flows will be measured every five years with portable metering. He stated that the City of Scottsdale will be responsible for routine maintenance of the system and training and inspections related to fats, oils and grease.

He stated that the Town will conduct a complete system assessment over the next five years. Based on the assessment, maintenance and replacement of infrastructure will be programed into the CIP.

Finally, he stated that the Town will not be required to evaluate purchasing additional capacity until 90% capacity is reached. He said when the Town does reach 90% and it can be demonstrated that the Town is built out, it may not be required to purchase additional capacity.

## 16-055 <u>Discussion of 2012-2014 Tax Code Amendments</u>

Town Clerk Duncan Miller briefed the Town Council on the 2012-2014 Tax Code Amendments. He stated that the Town adopted the Model City Tax Code (MCTC) in 1987. State law requires the Town to adopt the amendments as presented. He summarized the 18 amendments. He noted that the financial impact on the Town from the new exemptions and definitional changes would be di Minimis.

He reported that there was a new MCTC tax classification for wastewater utility service. There was Council consensus to set the rate at 0%.

He said the tax code amendments would be scheduled for a vote on March 10, 2016.

Mayor Collins recessed the meeting at 4:00 p.m.
