Marel and Bryan,

Thank you for the opportunity to meet with Bryan this morning.

Attached is our presentation (in pdf format) for the Planning Commission for Tuesday, 19 April.

Slide 3 shows that the majority of the existing buildings will remain. As was explained today, these buildings will be repainted with other similar appearance renovations. Also indicated in slide 3 is the buildings that will be demolished and replaced, and the surface parking area that will be removed.

Slide 4 lists the additions to the property, and slide 5 is the proposed site plan.

Slides 6 through 9 are the critical slides pertaining to the existing parking. 62% of the existing parking spaces are unused. The number of occupied parking spaces were counted 25 and 26 February 2022 – a peak-season fully-occupied weekend – every 30 minutes from noon on Friday through noon on Saturday. The maximum number of parked vehicles was 279, which occurred on Saturday morning at 9:30 AM. The maximum number of parked vehicles overnight was 227, which occurred at 3:00 AM Saturday morning.

Slide 10 determines the occupied parking spaces per conference room area on Saturday at 9:30 AM. All parked vehicles were counted – including employees, hotel guests, conference room users, delivery vehicles, service-people vehicles, and other vehicles on property for every purpose. However, only the conference room area was used to calculate the parking rate. If we had used the total area of all buildings on property, the area would have been much larger, which would have resulted in a much lower parking demand per building area. Thereby, the conference room parking rate is very conservatively high. The calculated parking demand is 1 parking-space-per-110 square feet of conference room area.

Slide 11 determines the occupied parking spaces per occupied hotel guest room on Saturday at 3:00 AM. All parked vehicles were counted – including employees, hotel guests, delivery vehicles, service-people vehicles, and other vehicles on property for every purpose. However, only the occupied hotel guest rooms were used to calculate the parking rate. Thereby, the hotel guest room parking rate is conservatively high. The calculated parking demand is 0.60 parking-space-per-occupied-hotel-guest-room.

Slide 12 provides the conservative assumptions for the parking need by building purpose. On the days of the parking count, 100% of the conference room users were also hotel guests. Therefore, their parked vehicles were on-property for their hotel guest room use, meaning that zero additional parked vehicles were needed. For the renovated Plaza Resort, we assumed 20% of the conference room users were not hotel guests, and therefore needed parking spaces. This is conservative and very unusual. The Plaza Resort clientele are people who stay in the hotel and use the conference rooms – for conferences, weddings, and other corporate and celebratory events.

Slide 12 also indicates that 100% of the spa and fitness building area will be used by people who are not otherwise at the resort. (People who are not staying in the hotel guest rooms or using the conference rooms.) This is also conservative, as the Plaza Resort owners believe that approximately 50% of the spa and fitness users will be hotel guests, and therefore will not need an additional parking space.

Slide 12 also indicates that 60% of the restaurant diners will be hotel guests, with 40% of the diners not staying in the hotel. The Plaza Resort is intended to provide people who are staying on the property all their needs on property. Certainly some people will want to visit other sites while they are here, but they do not need to leave the property. This is one of the reasons that three different and separate restaurants are planned. Each will have its own individual specialties and atmosphere. People who will be staying on property for several days will be able to have different dining experiences on different days without leaving the property. The Plaza Resort does want local people to also dine at the new restaurants, and therefore 40% of the diners are assumed to need parking spaces because they are not staying at the hotel. (Though it is recognized that many local people use ride-share for their restaurant meals, and therefore do not need parking spaces.) The Plaza Resort also hopes that guests at other Phoenix area hotels will also dine at the new restaurants – though these other restaurant guests will likely use ride-share or taxis and will not need parking spaces. Therefore assuming that 40% of the restaurant diners will need parking spaces is also very conservative.

Slides 13 and 14 determine the total number of parking spaces needed (without considering shared parking). The base determination is the number of parking spaces needed for hotel guests. The parking rate used is the existing parking rate of 0.60 parking-spaces-per-hotel room. The total number of hotel guests rooms with the renovated resort is 468, so 281 parking spaces are needed. Next is the number of parking spaces needed for the rare occasions when some people will be using the conference rooms without staying at the hotel. Therefore 59 parking spaces are added. Similarly, 121 additional parking spaces are needed for the restaurants to serve the diners that are not staying at the hotel. Finally, all spa and fitness room users are assumed to not be staying at the hotel, so an additional 27 parking spaces are needed. Important to recognize that the Plaza Resort intention is that the spa and fitness area will be closed at 6:00 PM, and therefore no spa and fitness users will occupy parking spaces during the prime restaurant dinner times. The total number of parking spaces, without considering shared parking, is 588 spaces.

Slides 15, 16, 17, and 18 are the results of three of the five shared parking models that were considered. Shared parking recognizes that the same parking space can be used by different vehicles at different times of the day. For example, a parking space might be needed for a spa and fitness user in the morning, and used by a restaurant diner in the evening. Similarly, a parking space might be used by a hotel guest overnight, and used by a restaurant diner for lunch or dinner who is not staying at the hotel. Each of the five different shared parking models has different assumptions, so all five were calculated and the maximum result was recommended. The shared parking model with the maximum required parking was the City of Waltham, Massachusetts (which is an affluent Boston suburb near the Massachusetts Institute of Technology and Cambridge). The City of Waltham shared parking model calculates that 571 parking spaces are needed. I believe it inappropriately non-conservative to utilize only one shared parking model for determining the necessary parking space number. For example, the Ritz-Carlton parking analysis and report only utilized the City of Scottsdale shared parking model. If we had only used the Scottsdale shared parking model, we would have recommended that the Plaza Resort needed 524 parking spaces. In my professional opinion, that would be non-conservative and would have been a dis-service to the Plaza Resort.

Slides 19 and 20 provide the calculated parking space need using the Paradise Valley guidelines and the parking requirements of five other nearby cities. (Please recognize that Paradise Valley does not have parking requirements for commercial properties, only guidelines.) These guidelines and requirements would result in an extremely large number of parking spaces. As stated in Slide 21, the two nearby resort hotels of Montelucia and Ritz-Carlton, as approved by the Paradise Valley Town Council, provide a small percentage of the Paradise Valley guidelines, as does our recommendation for the Plaza Resort.

Slides 22, 23, 24, and 25 indicate the number of additional parking spaces provided by the Plaza Resort for valet parking. Importantly, the underground parking area is designed to be used by normal drivers – following the design requirements for typical parking areas, providing wide two-way travel aisles and allowing all vehicles to enter and leave without moving other vehicles. However, the Plaza Resort intends to utilize the underground parking as valet-only. Valet service increases the number of available parking spaces. Similarly, some of the surface parking areas could also be utilized for valet-only parking which also increases the number of available parking spaces. Therefore, the Plaza Resort property can accommodate 656 parking spaces with valet parking.

Some additional comments.

The parking rates utilized for the hotel guest rooms and the conference rooms were determined from the parking demand on the existing property use by the existing owner-operator. This is the best possible determination technique for required parking. Other techniques use assumptions from other properties or agencies.

The Plaza Resort will use their conference rooms approximately 60% to 75% of the conference room business day (say 8:00 AM to 10:00 PM) for the entire year. And again, the conference room users are the hotel guests. Rarely is the conference room area used by non-hotel guests. A maximum of three days each year, the conference room might be used for lecture-style, no tables, no food-and-beverage-service events. These rare events are scheduled far in advance

and off-site parking might be necessary to accommodate such events. The Plaza Resort does not prefer this use of their property, and only accommodates certain specific clients for this use.

The Plaza Resort has entered into remote off-site parking agreements with the Millennium McCormick Scottsdale Hotel and the Scottsdale Railroad Park. These agreements were at the request of the Town of Paradise Valley, not the desire of the Plaza Resort. Importantly, the agreements are reciprocal, meaning both off-site properties can also use the Plaza Resort parking areas for their purpose, when necessary. The Plaza Resort knows that 571 parking spaces are excessive, so they are comfortable offering these other two entities the opportunity to use the Plaza Resort parking areas.

The existing parking areas are extremely excessive. Only 38% of the existing parking spaces are used by parked vehicles. To reinforce this fact, today the Plaza Resort was 100% occupied, though the vast majority of the parking spaces were unused. Furthermore, the Parking Report includes 26 aerial photographs dating back to 1996 showing the Plaza Resort parking areas mostly empty. The aerial photographs with the most parked vehicles are from the era prior to ride-share, and even the aerial photographs from those years show the Plaza Resort parking areas mostly empty.

I hope that I have answered all your questions. However, please inform me if I have not answered your questions. I also will be happy to answer other questions that may arise or you may have.

Finally, I would be happy to meet with you again at your convenience. I am available both Saturday and Sunday afternoon. I am also available Monday after 10:00 AM until as late as convenient for you. I am also available as early as you would like on Tuesday through 1:00 PM. 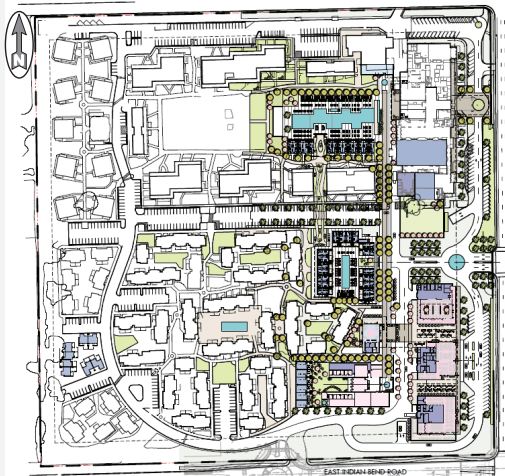

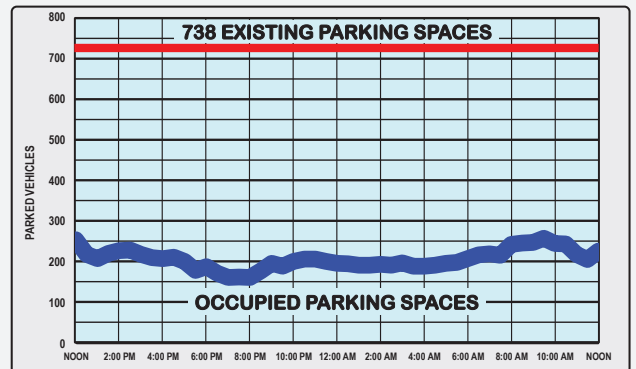

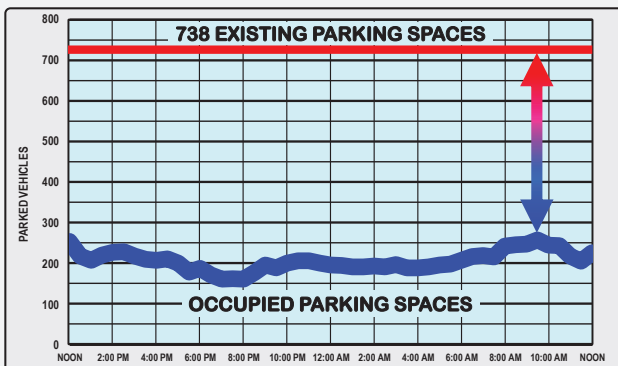

SITE PLAN



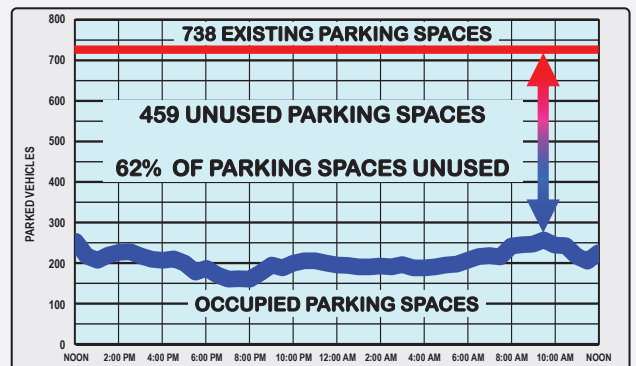

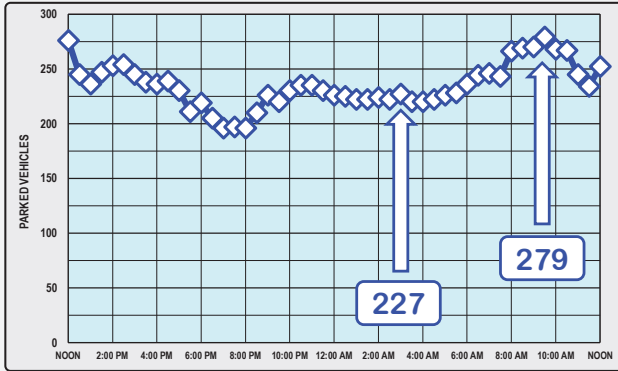

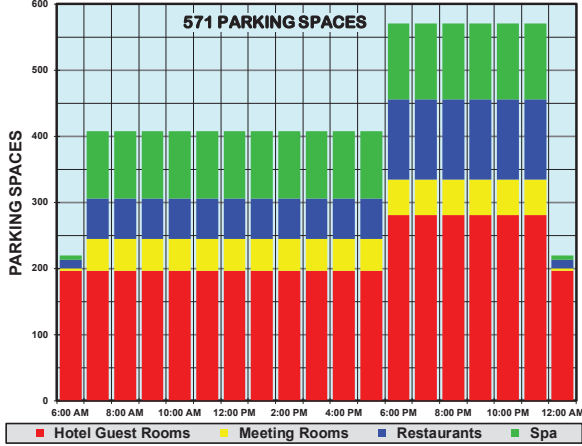

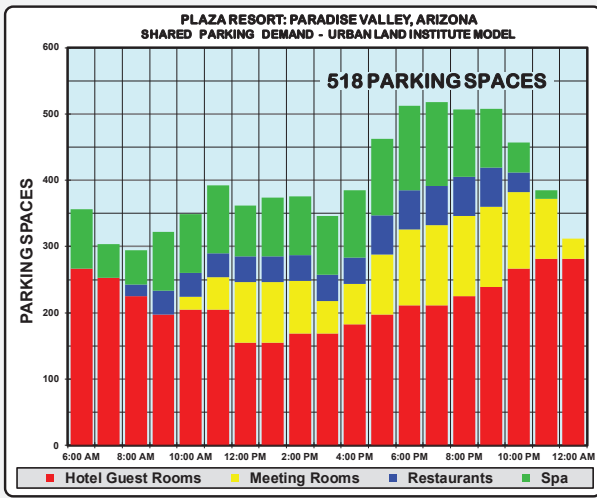

Good morning Chair Rose,

Thank you for your devotion to the Town of Paradise Valley... the wonderful oasis in the desert, which all of us are delighted to call home!

Our concern about the remodel of the Plaza resort is growing. In particular, it is hard to understand the proposed parking facilities.

From the slide utilized, at the most recent Planning Commission meeting, the statistics on parking utilization were presented as follows:-

<b>Total existing</b>	<b>737</b>
<b>Total proposed</b>	<b>571 (standard configuration)</b>
<b>Total proposed</b>	<b>656 (full valet mode)</b>
<b>Parking demand</b>	<b>588 (w/o shared parking)</b>
<b>Parking demand</b>	<b>571 (with shared parking)</b>
<b>Parking applying guideline rates</b>	<b>2,489</b>

As a resident, with no knowledge of parking requirements for a resort, these statistics seem to make no sense.

At the most basic level, the number of parking facilities will be reduced by 166 spaces. At the same time, the number of guest facilities will be increased by 60 rooms. To the uninitiated, surely that means the number of parking facilities needs to be increased by 60 spaces... not reduced by 166 spaces?

Furthermore, three new restaurants will be constructed... doesn't that mean an even bigger need for many more, rather than 166 less parking spaces?

Additionally, one has to assume that the existing conference facilities which, apparently, have hosted as few as 3 events per year, will need to be working towards increased utilization... potentially occupied for 365 days per year. Again, doesn't this point the way to a significant need for more, rather than less parking spaces?

There is mention of shared parking... what does that mean? Does it mean, for example, that staff will be working shifts and utilizing the same space? But, surely, that situation exists, already?

There is mention of valet parking. Where will these vehicles be sited? The obvious place is across the road in retail and business space which is likely to be unused, during the evening. However, these spaces will be occupied during the day. Is the resort planning to enter into a contract with the owners of these parking facilities? Furthermore, doesn't it seem like an accident waiting to happen that valet staff might be driving cars across the road... and then running, across a busy arterial road with a speed limit of 45 mph, back to the resort.

Finally, isn't the "parking applying guideline rates" of 2,489 hard to comprehend? What does this mean?

On the positive side, of course, we are thrilled that the new owners of the Plaza intend to make a significant investment to update the resort. However, residents are concerned about the parking proposals... among other aspects.

We trust that, with collaboration, residents can look forward to an updated resort which does not undermine the safety, density, disturbance level, and charm of our Town.

Again, thank you to all Planning Commissioners for the many hours expended, already, on considering this application. Your dedication is much appreciated.

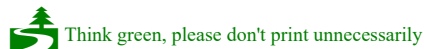

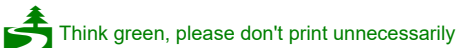

## **Project Proposal**

The Applicant, 7200 SCOTTSDALE RD OWNER LP, is proposing to amend the Special Use Permit to renovate and renew The Scottsdale Plaza Resort, a 36-acre property located at 7200 N Scottsdale Road, Scottsdale AZ 85253 (Maricopa County Assessor Parcel Numbers: 174-49-001B, 174-49-001A, 174-49-002A). ### **Neighbor Reception Summary**

The neighbors were invited to the Reception to meet the new ownership team and learn about the proposed and much needed improvements planned for the Resort property. There were 3 attendees at the meeting as documented on the Neighbor Reception sign in sheet.
