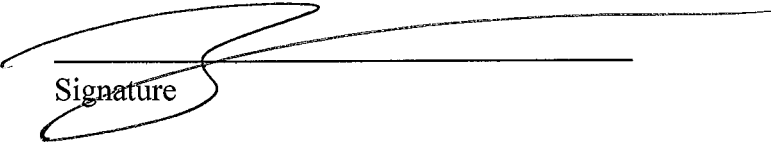

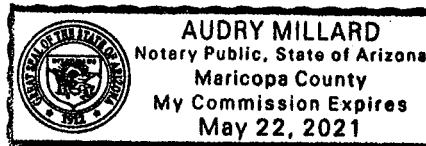

Dear Property Owner or Interested Citizen:

Our firm represents Jamel Greenway, LLC regarding its proposed redevelopment of the 2.13-acre medical plaza located at 7125 E. Lincoln Drive in Paradise Valley, AZ as shown on the enclosed Aerial Map (the "Property"). As you may know, this site was originally approved for a medical office Special Use Permit (SUP) in the 1970s. A 2-story medical office complex was subsequently constructed on the site, and it has remained relatively unchanged in the decades since then. In May of this year, however, we applied for an amendment to the existing SUP to redevelop the site with a brand new two-story state-of-the-art medical office building in its place.

The existing medical office is approximately 50 years old and in need of a drastic overhaul. The existing structure has reached the end of its useful life, and in order to maintain stride with medical technology, energy efficient building design, and modern architecture, construction of a new medical office building is necessary. The proposed medical office will substantially enhance the visual appeal of the site and provide the community with medical facilities incorporating the most cutting-edge technology available today. The site will be completely redeveloped with a new two-story medical office building with a footprint similar to the existing building, along with new landscaping and streetscape.

Our goal is to provide the community with a newer, better version of the medical office building that exists on the property today. To achieve this goal, some minor changes to the existing approved height, setbacks, and floor area are necessary. However, the proposed building will still be limited to two stories and maintain most of the existing footprint – in line with the building that exists on the Property today. These changes will allow us to move forward with a state-of-the-art medical office building that will be an asset to the community for decades to come.

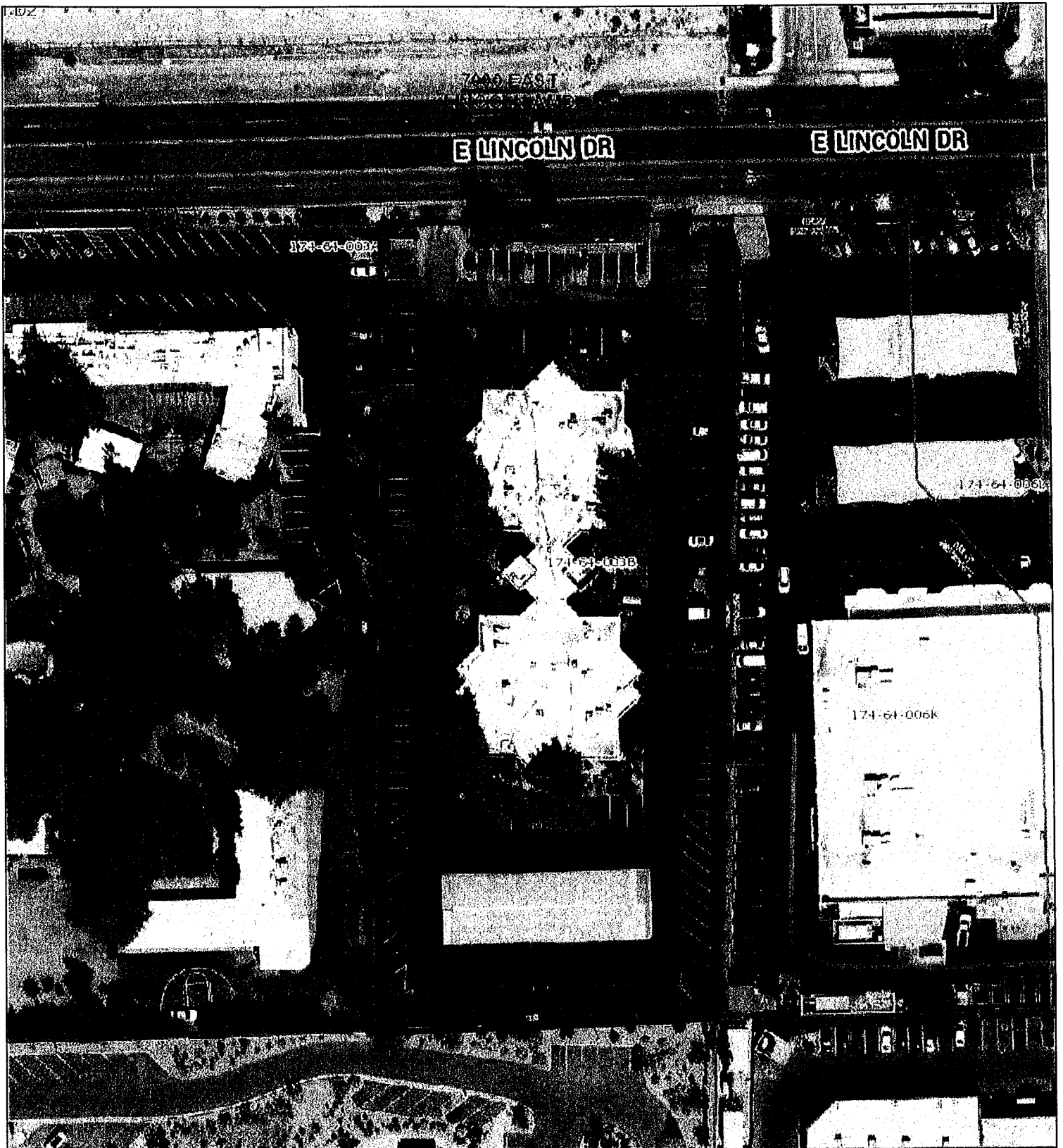

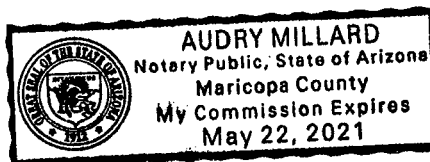

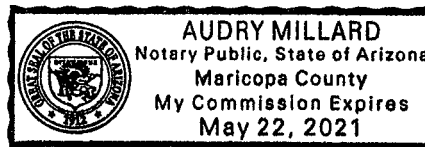
