
Please accept this letter with the attached resume as my application for reappointment as an Associate Judge of the Town of Paradise Valley Municipal Court.





I understand there is additional information you would like which is normally not included in a resume. The purpose of this cover letter is to provide such information and to highlight some attributes.

- After a successful business career, I went to law school at 36 years of age. I went through in 2 years and 4 month and graduated *cum laude*. Having successful business and law careers have given me a broader understanding of how the law and business work together to drive some defendants' decision making.

This provides the Town with a Judge who quickly responds when a Judge is needed; e.g. for an Order of Protection, warrant, or saving the Police Department the time required to take an in custody prisoner picked up on a warrant to the Fourth Avenue jail. By coming in, the Town may hold the prisoner for a short time instead of taking one or two police officers off the street for two or more hours, transporting and booking the prisoner downtown. In addition to other benefits, this saves the Town money.
- Written motions come in and go into the Judge's Box, to be acted on when a Judge comes in. These motions have a tendency to pile up. The Court does not schedule a Judge on Thursdays and is closed Friday through Sunday. So the motions do not sit in the Box for an extended period when a judge is unavailable, I have voluntarily stopped by on Thursdays, as needed, to clear the box. This prevents motions from being held over for long weekends.
- I have attended approximately 400 hours of Judicial Training provided by the Arizona Supreme Court Educational Division in the last 5 years. In addition, I have attended all sessions at the annual Judicial Conferences in Tucson or Paradise Valley. Further, although not required, I usually attend specialized training provided for Judges dealing with current issues between conferences and have done extensive self-study to extend my abilities as a Judge. As a volunteer, all these hours are put in because I love the job and, of course, not for a paycheck.

- A Judge's job is first to attempt to change behavior. I run a dignified but relaxed Courtroom. Many defendants do not know what to expect and come to Court with a sense of trepidation. I treat everyone with respect and try to make them comfortable. I have spent many years on the other side of the bench and know the Judge's attitude is important in making sure justice is done. When defendants leave the Court, they know they were listened to and have had their day in Court. More often than not, even when held Responsible or Guilty, they will say, "Thank you". Defendants will leave the Court with a good impression of Paradise Valley.
- It is important to make it clear, on the record, if the Defendant feels I have erred at the conclusion of the case, they have 14 days to file a Notice of Appeal. I advise how they file an appeal if there has been no plea. Thus helping to protect our Defendant's rights. *As of this writing, none of my decisions have been appealed.*
- Teaching in the Criminal Justice program at Phoenix Collage has made me more sensitive to Defendants' Constitutional rights, which has helped make me a better Judge.
- Performing weddings is one of the most gratifying public services a judge can do. I never charge for this service, although it is allowed for when performed outside the Courthouse. It is my honor to provide this service. My next scheduled wedding is this October.
