Dear Neighbor:

Paradise Valley Medical Plaza is located at the southwest corner of Jackrabbit and Scottsdale Roads. In 1979 the Town granted the original Special Use Permit for a medical clinic. Dr. John Simons, a well-known plastic surgeon, maintained his private practice at the site for over 20 years. While Dr. Simons no longer works from the property, a significant focus for Paradise Valley Medical Plaza continues to be elective plastic surgery. In 2003, the Town approved a major amendment to the Special Use Permit for additional improvements at the site.

As the area and practices have evolved over the last few years, we have decided to refine the site plan. We recently submitted an application to the Town of Paradise Valley for an intermediate amendment to the existing Special Use Permit. Proposed changes include the addition of a single-story 10,000 square foot building on the west side of the campus for use as medical offices and/or surgical facilities, a new parking area and parking canopies, and additional landscaping on the west side. Also, the existing patient drop-off area on the west side of the building has been relocated and a screen wall has been added between the drop-off and the neighbors to the west, resulting in a noticeable noise reduction.

On Tuesday, December 18, the Town of Paradise Valley Planning Commission will be holding a public meeting/hearing to consider our request for an intermediate amendment to the current Special Use Permit; a copy of the notice is enclosed. Prior to that meeting, we would like to **invite our neighbors to a meeting at Town Hall on Thursday, December 6 at 6:30 pm**. At this meeting, we will go over our plans, explain what is being revised, and answer your questions. We hope to see you then. Attached is a copy of the attendance sheet from the meeting; five people (including three representing the applicant) attended the meeting.






The format was an informal discussion and questions by those in attendance. The main topics of interest and concern were:

- Revised site plan and site characteristics
- Traffic flow

The project was well received by those in attendance. One neighbor was concerned about new development on the northwest corner of the site and seemed supportive of the proposal once learning that no new development was planned for that area. The second attendee was the listing agent for the neighbor immediately to the west of the site, who stated that the immediate neighbor's property is being sold. The realtor noted that he did not think the proposal would be a problem and stated that he would pass along information to the immediate neighbor.

Back in November 2018, we sent a notice about the upcoming Planning Commission hearing on our request for an intermediate amendment to the existing Special Use Permit for the Paradise Valley Medical Plaza, located at the southwest corner of Jackrabbit and Scottsdale Roads. We are happy to report that the Planning Commission recommended, by a 6-0-vote, that the request be approved.

The last major amendment to the approved plans occurred in 2003. As the area and practices have evolved over the last few years, we have decided to refine the site plan. Proposed changes include the addition of a single-story 10,000 square foot building on the west side of the campus for use as medical offices and/or surgical facilities, a new parking area and parking canopies, and additional landscaping on the west side. Also, the existing patient drop-off area on the west side of the building has been relocated to be further away from the property line. More significantly, a screen wall has been added between the drop-off and the neighbors to the west, resulting in a noticeable noise reduction.





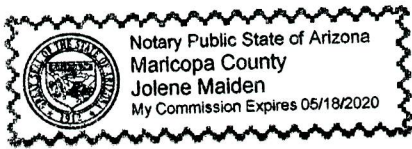
