

1 A RESOLUTION OF THE MAYOR AND COMMON COUNCIL
2 OF THE TOWN OF PARADISE VALLEY, ARIZONA, REDUCING
3 THE SPEED LIMIT ON A SEVEN HUNDRED (700) FOOT
4 PORTION OF INVERGORDON ROAD IMMEDIATELY NORTH
OF ITS INTERSECTION WITH MACDONALD DRIVE IN THE
TOWN OF PARADISE VALLEY, AND DECLARING AN
EMERGENCY

5 Sec. 1. WHEREAS, the Town of Paradise Valley has determined
6 the following as a result of engineering and traffic investi-
7 gation:

- 8 1. Invergordon Road is a two lane north and
9 south bound roadway that carries a heavy
10 volume of traffic between, on the south,
11 MacDonald Drive, and, on the north, Lincoln
12 Drive; and
- 13 2. There are four-way stop sign traffic controls
14 at the intersection of Invergordon Road and
15 MacDonald Drive; and
- 16 3. The school and church located on Invergordon
17 Road within seven hundred (700) feet of the
18 north right-of-way line for MacDonald Drive
19 increase traffic congestion, and excessive
20 speed produces hazards for children walking
21 along Invergordon Road to and from the
22 school; and

23 WHEREAS, A.R.S. 28-703 authorizes a Town to determine
24 and declare reasonable and safe maximum speed limits for streets
25 within the Town, and

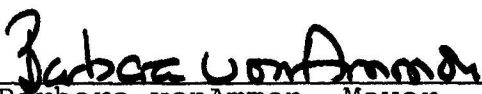
26 WHEREAS, Section 11-2-1 of the Code of Ordinances of
27 the Town of Paradise Valley authorizes the Town Council to
28 change the speed limit on specified streets by resolution,

29 THEREFORE, BE IT RESOLVED by the Council of the Town
30 of Paradise Valley that the maximum speed limit on that portion
31 of Invergordon Road between MacDonald Drive and a point seven
32 hundred (700) feet north of the north right-of-way line of

MacDonald Drive, in the Town of Paradise Valley, is hereby
determined and declared to be twenty-five (25) miles per hour.

Sec. 2. WHEREAS, the immediate operation of the provisions of
this resolution is necessary for the preservation of the public
peace, health and safety, an emergency is hereby declared to
exist, and this resolution shall be in full force and effect
from and after its passage by the Common Council of the Town of
Paradise Valley, Arizona, and approval by the Mayor.

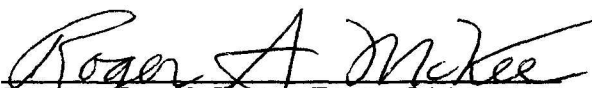
