

RESOLUTION NUMBER 2024-19

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF PARADISE VALLEY, MARICOPA COUNTY, ARIZONA, CANVASSING, DECLARING, AND ADOPTING THE RESULTS OF THE ELECTION HELD FOR THE OFFICE OF MAYOR ON NOVEMBER 5, 2024.

WHEREAS, the Town of Paradise Valley, Arizona (the “Town”), held a general election on November 5, 2024, for the non-partisan runoff election for the Office of Mayor; and

WHEREAS, pursuant to Arizona Revised Statutes (“A.R.S.”) § 16-204, the Town’s election was consolidated with the Maricopa County General Election ballot; and

WHEREAS, the election returns have been presented to, and have been canvassed by, the Maricopa County Board of Supervisors and the Mayor and Council of the Town pursuant to A.R.S. §§ 16-642 and 16-646.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Paradise Valley, Arizona, as follows:

Section 1. The total number of valid ballots cast at said general election, as shown by the poll lists, was 9,675.

Section 2. The total number of rejected ballots equaled 30 (three with no signatures and 27 with bad signatures), and the number of ballots returned late equaled six.

Section 3. The total number of provisional ballots equaled 52, of which 12 were counted and 40 were not counted (14 were not registered to vote, 18 were not eligible to vote in this election, and eight were rejected conditional provisional ballots (sufficient identification was not provided by the deadline)).

Section 4. The candidates for the Office of Mayor were as follows:
