    - Zoning for non-residential uses
  - Zoning Ordinance/Map Amendments
  - Long-Range Plans (General Plan, Area Plans)
  - Lot splits (less than 2.5 net acres, not by unanimous vote)
  - Preliminary Plats (if deviations)
  - Final Plats (if deviations)



### **ROLE OF PLANNING COMMISSION (CONT)**

- Hear and decide, with appeals to Council
  - Minor Special Use Permits
  - Conditional Use Permits
    - Water booster stations
    - Private road
    - Antennas
  - Lot Splits (less than 2.5 net acres by unanimous vote)
  - Preliminary Plats (No deviations)
