Mayor Stanton called to order the Town Council Meeting for Thursday, September 25, 2025 at 3:00 PM in the Town Hall Boardroom, 6401 E. Lincoln Drive, Paradise Valley, AZ 85253.

2. STUDY SESSION ITEMS

25-213 Discussion of Bond Financing Options

Mark Reader, Managing Director, Stifel, briefed the Council on the Arizona Expenditure Limitation Law and the potential issuance of excise tax revenue bonds. He explained that amounts received from the issuance of bonds and payment of principal and interest on such bonds are exempt from the expenditure limit. He provided data on Arizona cities and towns which have adopted an alternative expenditure limit and recent Arizona County tax-exempt borrowing to fund capital improvement projects. He reported on current bond market trends and scenarios for sale of bonds.

25-214 Discussion of Arizona Expenditure Limitation Adjustment Options

Town Clerk Duncan Miller explained that the Arizona Expenditure Limitation Law is a constitutional amendment approved by the voters in 1980. The purpose of the law is to control local government spending and ensure that future increases in spending are tied to changes in population and inflation. The law also allows for exclusions such as debt service, capital leases, grants, excess Highway User Revenue Funds, and investment income. Each year the spending limit is calculated by the Economic Estimates Commission by adjusting a 1979-1980 base year for population growth and inflation. He said the Town's annual expenditures are approaching the limit. He presented the four options authorized by statute to adjust the limitation and their pros and cons. Each option requires voter approval at a regular primary or general election.

- 1. Home Rule
- 2. One-time Override
- 3. Capital Projects Accumulation Fund
- 4. Permanent Base Adjustment

He presented a sample timeline to place a question on the November 2026 ballot.

Before deciding if and when the Town's expenditure limit should be adjusted, the Council requested additional information on the capital improvement program including long-term project planning, timelines, cost estimates, and funding projections; and information on expenditure limitation trends and bond financing options.

25-222 Presentation by Congressman David Schweikert regarding Paradise Valley Post Office

Congressman David Schweikert addressed the Council regarding the Town's successful efforts to appeal the decision by the United States Post Office to close the contract postal unit in Town Hall. Town officials coordinated with the Congressman who pursued the Town's cause at the federal level. He stated that Paradise Valley's Post Office serves as a model for how other contract stations can continue to operate.

25-219 Recognition of Artist-in-Residence Barbara Bayless Lacy for Displaying her Artwork at Town Hall

The Mayor and Council recognized Barabar Bayless Lacy for displaying her art at Town Hall over the last year and presented her with a plaque commemorating her time as the featured artist for 2024-2025.

PV Arts Board Chair Colleen Steinberg presented the Board's annual report to Council. She summarized the feature artis program, student art show, and artists' studio tour.

25-216 Hillside Building Committee Update

Hillside Building Committee Chair Scott Jarson presented the Committee's annual report to Council. He said the Committee's role is to review plans for new and modified construction on hillside properties to promote compliance with development regulations. He summarized the types of applications they received, development trends, and educational outreach efforts.

Discussion and Possible Action to Authorize Expenditure of Budgeted Funds for Information Technology Managed Services and Annual Software Renewals with Sentinel Technologies, Inc

IT Team Lead Taylor Hunter presented a request to spend budgeted funds for information technology managed services and annual software renewals with Sentinel Technologies. He said the Town has worked with Sentinel since 2021. They provide 24/7 systems and cyber security monitoring, software licenses and subscriptions, and other professional services for continuous improvements. The total annual contract expenditure is \$520,000. This is a routine notification to Council, as required by budget management policies, of an expense to a single vendor in excess of \$100,000.

Discussion and Possible Action to Adopt Ordinance 2025-03, Amending Chapter 2of the Town Code: (i) Article 2-2, Section 2-2-2 Relating to the Annual Process for Selection of the Vice Mayor, and (ii) Article 2-6, Section 2-6-6, Relating to Modified Posting Requirements to Align with Changes in State Law

Town Attorney Andrew McGuire stated that the Council reviewed draft Ordinance 2025-03 at the Council study session on June 12, 2025. The ordinance proposes to replace the current process of electing a Council Member to serve a one-year term as vice mayor with a rotating process based on seniority. Subsequent to the meeting in June, an amendment in a different section of Chapter 2 was added to the ordinance to bring the Town Code into conformance with a change in state law related to public notice posting requirements for adopted ordinances.

Residents Jini Simpson, Rick Adams, and Paul Dembow spoke in opposition to the ordinance. Resident Janie White did not speak but submitted a comment card in opposition to the ordinance.
