DEDICATION

KNOW ALL MEN BY THESE PRESENTS: That the Phoenix Title and Trust Company, an Arizona Corporation, Trustee, has subdivided under the name of MUMMY MOUNTAIN PARK, that part of Sec. 4, T.2N., R.4E., G. & S.R., B. & M., Maricopa County, Arizona, described as follows:

Beginning at the NE Cor. of said Sec. 4, said corner being a G.L.O. Post and the true point of beginning; thence N84°39'W along the North line of said Sec. 4, 2504.20 feet to a G.L.O. Post marking the N 1/4 Cor. of said Sec. 4; thence N89°08'W along the North line of said Sec. 4, 2724.36 feet to a G.L.O. Stone marking the NW Cor. of said Sec. 4; thence S2°46'30"W along the West line of said Sec. 4, 1479.54 feet; thence N89°47'20"E, 1351.19 feet; thence S0°12'10"E, 1447.01 feet; thence S61°15'40"E, 262.05 feet; thence East, 421.93 feet to a point marking the beginning of a curve to the right having a central angle of 62°27' and a radius of 38.21 feet; thence along the arc of said curve to the right, 41.65 feet; thence S66°42'E, 92.41 feet to a point marking the beginning of a curve to the left having a central angle of 40°16' and a radius of 283.42 feet; thence along the arc of said curve to the left, 199.18 feet; thence N73°02'E, 375.00 feet to a point marking the beginning of a curve to the right having a central angle of 16°59'15" and a radius of 1004.18 feet; thence along the arc of said curve to the right, 297.73 feet; thence S89°58'45"E, 2316.68 feet to a G.L.O. Stone marking the E 1/4 Cor. of said Sec. 4; thence N0°09'W along the East line of said Sec. 4, 2660.75 feet to the true point of beginning; and except that part thereon as EXCEPTION upon the plat hereon.

and hereby publishes this plat as and for the plat of said MUMMY MOUNTAIN PARK, and hereby declares that said plat sets forth the location and gives the dimensions of the lots, tracts and streets constituting same and that each lot, tract and street shall be known by number, letter or name given each respectively on said plat and hereby dedicates to the public for use as such the streets as shown on said plat and included in the above described premises. Easements are dedicated for the purposes shown.

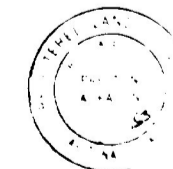
