1. CALL TO ORDER / ROLL CALL

Mayor Collins called to order the Town Council Meeting for Thursday, October 8, 2015 at 4:00 p.m. in the Town Hall Boardroom.

2. STUDY SESSION ITEMS

15-215 Discussion of Marquee Street Identification Signs

Engineering Services Analyst Jeremy Knapp presented seven options for marquee street identification signs for twelve signalized intersections. He asked for direction on style, lighting vs non-lighting, whether to include the town seal, how they should be

mounted, and custom metal work.

There was Council consensus to proceed with the design for Option A non-lighted, no seal, and flag-mounted. The estimated cost quote for Option A was \$220,000. The Council also asked for a mockup of a lighted version of Option A.

15-221 <u>Discussion of Drone Ordinance</u>

Town Attorney Andrew Miller presented a draft ordinance on unmanned aerial vehicles (Drones). Staff showed videos demonstrating drone videos flying at different heights.

Mr. Miller explained that the ordinance differentiates between drone operation over private property and public property and regulates the use of drones based on the following categories: commercial use, recreational use, and emergency/investigatory use.

There was Council discussion about potential liability, legal challenges, and federal preemptions if the draft ordinance were adopted. There was discussion about limiting the restrictions on commercial use and registration if a commercial operator is acting on behalf of a property owner to take video of their property, such as for real estate marking purposes. It was also suggested that the first offense should be a civil offense.

Staff was directed to research the liability questions and schedule the ordinance for a public hearing to receive comments from commercial operators and the public. The hearing would then be continued to a future date to take into consideration the public comments.

15-220 Discussion of Construction Noise Ordinance

Town Manager Kevin Burke presented draft language amending the noise ordinance granting the Town Manager the authority to grant waivers on time and day restrictions in the noise ordinance. He noted that Town Managers have exercised this power in the past, however, the current code does not expressly grant the manager that authority.

There was Council discussion to revisit the noise ordinance to make other changes related to prohibiting work on Saturdays prior to 7:00 a.m. There was Council consensus to schedule the ordinance as drafted for a vote at the next meeting.

Mr. Burke presented an easement and purchase agreement related to the purchase of property for the construction of a public safety communications tower on property owned by Jane Marie Westhoff in the vicinity of 6800 E Highlands Drive. He stated that the agreement provides for the location of a communications antenna and associated equipment building along with the future Westhoff home. Mr. Burke summarized the terms of the purchase and settlement agreement.

Doug Westhoff addressed the Council regarding the esthetic details and location of the tower.

A motion was made by Council Member Sherf, seconded by Council Member Hamway, to approve the Easement Purchase Agreement at 6824 East Highland Drive. The motion carried by the following vote:

15-216 Award of contract to Dibble Engineering in the amount of \$420,051 for engineering consulting services related to watershed studies

Engineering Services Analyst Jeremy Knapp presented the engineering services consulting contract to study the Cherokee and Cheney watersheds. He discussed the selection process, scope of work, budget, and schedule. He stated that the Council budgeted \$500,000 for the studies and the contract award was for \$420,051. The project schedule is eleven months.
