- CONDUIT ON ROOF TOPS SHALL BE 3/4-INCH TRADE SIZE AND SHALL FOLLOW PARAPET WALLS IN AS MUCH AS POSSIBLE. SHORT RUNS OF CONDUIT BETWEEN ROWS OF SOLAR PANELS SHALL BE RUN CLOSE TO THE ROOF SURFACE (4" ABOVE).
- WHERE CONDUIT CROSSES FROM ONE ROOF SURFACE TO ANOTHER, IT SHALL BE POSITIONED SUCH THAT IT IS NOT VISIBLE BY A PERSON STANDING AT GRADE.
- SOLAR PANELS SHALL NOT BE VISIBLE FROM ADJACENT PROPERTIES.

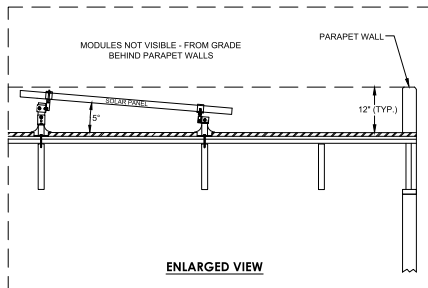
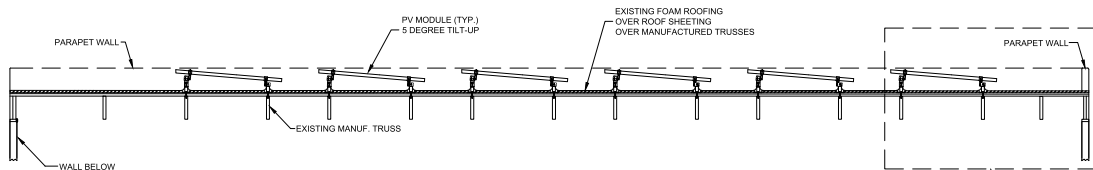
