PROJECT SCOPE

- 12,000 linear feet of new sidewalk with ADA ramps at intersections
- Retaining walls and culvert extensions where necessary
- Landscaping and irrigation
- Pedestrian wayfinding signage
- Right-of-way/easement acquisition, environmental clearances
- Coordination with on-going Bike/Ped Study and Visually Significant Corridors Study



INTERGOVERNMENTAL AGREEMENT

- ADOT is required to administer the project due to the award of federal funds
- Requires a \$30,000 Project Management and Design Review fee
- Ensures town complies with all federal requirements
- ADOT advertises, bids, and oversees construction



DESIGN ENGINEER SELECTION PROCESS

- Engineering services are required to be selected by qualifications per Arizona Revised Statutes Title 34
- Solicited SOQ's in July 2016, received 11 qualified responses
- Selection committee included representative from ADOT
- Interviewed top five firms
- Kimley»Horn was the unanimous decision
