#### 2. STUDY SESSION ITEMS

#### 18-358 Reflection Path Dedication

Mayor Collins and the Town Council dedicated the Paradise Valley Reflection Path located in the central landscaped area of the Town Hall complex parking lot. The Path features memorial plaques and remembrances of notable Town leaders and volunteers. The Public Works Department was recognized for designing and constructing the path.

# 18-362 Discussion of Draft Ordinance No. 2018-16, a Proposed Amendment to Article XVI, Home Occupation; Section 1603, of the Town Zoning Ordinance

Town Attorney Andrew Miller presented draft Ordinance 2018-16 to address complaints about parking on non-driveway surfaces at home occupations. The ordinance seeks to remedy the aesthetic problems and general nuisance issues created by such parking.

Responding to a question from Council, Planning Commission Chair Daran Wastchak stated that the only public comment received at the Planning Commission was from a resident who asked for confirmation that the ordinance only applied to home occupations.

Mr. Miller stated that short-term residential property rental is considered a home occupation and that the ordinance would apply. He clarified that enforcement would follow the standard civil complaint process in Town Code.

There was Council consensus to schedule the ordinance as drafted for a vote on October 25th.

# 18-361 Discussion and Direction Regarding SUP Managerial Amendment Process

Mr. Miller presented potential changes to the Special Use Permit section of the Code related to the Managerial Amendment process. It was noted by some Council Members that there is currently no appeal process for Managerial Amendments.

There was Council consensus to bring back a draft ordinance that included the following elements:

- Better define Section 1102.7(A)(4)
- Approved Managerial Amendments must be forwarded to the Town Council
- If three Council Members provide a written request to the Town Manager to review an amendment it shall be scheduled for discussion at the next Council Meeting.

# 18-360 Discussion of Amendments to the Hillside Development Regulations in Article XXII of the Zoning Ordinance; Draft Ordinance 2018-15

Mr. Miller presented draft Ordinance 2018-15 which makes the following minor changes to Zoning Article XXII Hillside Development Regulations:

- 1. Update certain definitions
- 2. Adds a pre-application submittal requirement
- 3. Provides for expiration of Hillside applications
- 4. Clarifies language related to requests to remove a property from hillside designation

There was Council consensus to change the term 'Concept Plan Review' to 'Concept Plan Presentation' as the word 'review' might be misinterpreted to be dispositive.

Mr. Miller stated that the ordinance would be scheduled for a public hearing on October 25th.

#### 18-356 Visually Significant Corridors Master Plan Discussion #1

Community Development Director Jeremy Knapp provided a broad overview of the Visually Significant Master Plan. Preparation of the Plan was both an implementation measure of the 2012 General Plan and a Town Council Quality of Life initiative.

He described each of the five sections of the plan, the Planning Commission's favorable recommendation, and the public input process.

John Griffin with Environmental Planning Group (EPG), the firm retained to develop the Plan, commented on the public outreach efforts.

The Council offered their initial feedback on the Plan. Concerns were expressed about: the design treatment and possible rest and reflection areas at the intersection of Lincoln Dr and Tatum Blvd; how this would financially impact private property owners adjoining the corridors; and if the Plan was meant to be a set of design guidelines or requirements.

The Council requested additional information on how the Plan would be implemented and if the Police Department and/or Engineering Department have any traffic safety concerns related to any of the designs. A suggestion was also made to include only snout weevil-resistant agave in the landscaping section.

Mr. Knapp stated that there would be an opportunity for the Council to discuss the Plan in greater detail at the next meeting.

Discussion of Major Special Use Permit Amendment - Statement of Direction (SUP-18-05). 7101 E Lincoln Drive - SmokeTree Resort - 1st Review

Mr. Knapp summarized a request to redevelop the Smoke Tree Resort. The resort site included the following proposed uses:

- 150 traditional hotel guest room keys for transient occupancy owned by the resort owner. Presently, the resort has only 23 of its 32 guest rooms in use.
- 30 resort residential units at approximately 1,250 square feet with lock-off feature and available for transient occupancy through the resort.
- Restaurant and bar/lounge in a similar location to the prior on-site restaurant.
- Accessory uses such as a fresh food market, café/eatery, micro-brewery, speakeasy, pop-up retail, coffee shop, florist, sandwicheria, bakery, and epicurean retail and sundries.
- Indoor and outdoor space for events, including a resort pavilion for banquets/meetings and pool areas.

He noted that the first formal step in the Special Use Permit (SUP) process if for the Council to adopt a Statement of Direction (SOD). The Council discussed and provided comments on the following SOD topics:

- 1. Use
- 2. Density
- 3. Lot Coverage/Floor Area Ratio
- 4. Height
- 5. Viewsheds
- 6. Setbacks
- 7. Impact to Adjacent Uses
- 8. Landscaping
- 9. Infrastructure improvements
- 10. Traffic, Parking, Access, and Circulation
- 11. Signage
- 42. Community Spaces/Public Benefit There was Council consensus to delete this item.
- 13. Context Appropriate Design

Mr. Knapp stated he would incorporate the Council's direction and bring back a draft SOD for review at the next meeting.
