

RESOLUTION NUMBER 2026-10

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF PARADISE VALLEY, ARIZONA RECOGNIZING THE PARADISE VALLEY YOUTH COUNCIL AS AN INDEPENDENT AND SELF-GOVERNING CIVIC ORGANIZATION DEDICATED TO SERVING THE YOUTH OF PARADISE VALLEY.

WHEREAS, the Town of Paradise Valley (the “Town”) encourages and supports the volunteer efforts of its residents in service to the Town, including service as the Mayor and Town Council (the “Town Council”), board and commission members, municipal judges, police volunteers, and the like; and

WHEREAS, the youth of Paradise Valley have not historically had specific volunteer opportunities with the Town; and

WHEREAS, the Paradise Valley Youth Council (the “Youth Council”) organized over the last year to provide Paradise Valley youth an organization dedicated to civic and cultural enrichment, as well as volunteer opportunities within the community; and

WHEREAS, the Youth Council has been active in the community and with the Town, including volunteering at the Veteran’s Car Show, the annual Martin Luther King Junior event, field trips to the Police Department and the Court, and numerous other civic minded activities; and

WHEREAS, the Youth Council has respectfully requested the Town’s support through the adoption of this resolution.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Paradise Valley, Arizona, as follows:

Section 1. The recitals above are hereby incorporated as if fully set forth herein.

Section 2. The Youth Council is hereby recognized as an independent and self-governing civic organization dedicated to serving the youth of Paradise Valley and the Paradise Valley community through civic, cultural, and charitable activities.

Section 3. The Youth Council will not function as a board or commission of the Town, and is advisory only to the Mayor. Accordingly, no agenda posting or meeting minutes will be required. However, the Mayor is authorized to appoint from time to time a member of the Town Council to serve as a volunteer liaison to the Youth Council.

Section 4. The Mayor is authorized to provide the Youth Council with the opportunity to attend specified civic training and learning opportunities, including the annual League of Cities and Towns Youth Conference.

Section 5. The Mayor, the Town Manager, the Town Clerk and the Town Attorney are hereby authorized and directed to take all steps necessary to carry out the purpose and intent of this Resolution.
