2. **Contract Intent:** The Town is interested in taking advantage of technological advances in the field to reduce traffic collisions and encourage voluntary compliance with traffic laws, and create a safer environment for the residents, visitors and motorists in Paradise Valley. The Town requested proposals from qualified vendors with demonstrated experience in providing complete automated photo enforcement services.

b) Pricing/Cost of Services (30 points)

c) Firm Qualifications and Key Personnel (20 points)

d) References, Warranty, Exceptions (10 points)

In the Best and Final evaluation, the results of the evaluation scoring were as follows:


