



KNOW ALL MEN BY THESE PRESENTS: That Allen Chase and Lucille T. Chase, his wife, owners of the SW 1/4 SW 1/4, the W 1/2 W 1/2 SE 1/4 SW 1/4, the South 62 ft of the NW 1/4 SW 1/4 and the South 62 ft of the W 1/2 W 1/2 NE 1/4 SW 1/4 of Section 9, T. 2N. R. 4E., G & S R. M., Maricopa County, Arizona, have caused the premises to be surveyed and subdivided under the name of NAUNI VALLEY RANCH and hereby publish this plat as and for the plat of said NAUNI VALLEY RANCH, and hereby declare that said plat sets forth the location and gives the dimensions of the lots, tracts, streets and easements constituting same, and that each lot, tract and street shall be known by the number, letter or name given to each respectively on said plat, and we hereby dedicate to the public for use as such the streets known as MacDonald Drive and 56th Street, and the use as such for public utilities the easements as shown on said plat and included in the above described premises.
