

RESOLUTION NUMBER 2016-25

**A RESOLUTION OF THE MAYOR AND COUNCIL
OF THE TOWN OF PARADISE VALLEY,
MARICOPA COUNTY, ARIZONA, DECLARING
AND ADOPTING THE RESULTS OF THE
GENERAL ELECTION HELD FOR PROPOSITION
499 ON NOVEMBER 8, 2016**

WHEREAS, the Town of Paradise Valley, Maricopa County, Arizona, held a General/Special Election on the 8th day of November, 2016 for for Proposition 499 seeking voter approval to permanently adjust the expenditure base of the Town of Paradise Valley as determined by the Arizona State Economic Estimates Commission; and,

WHEREAS, the election returns have been presented to, and have been canvassed by, the Town Council of the Town of Paradise Valley.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Paradise Valley, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of valid ballots cast at said election, as shown by the poll lists, was 8,665;

SECTION 2. That the total number of rejected ballots equaled 34 (11 no signatures, 15 returned late, 8 bad signatures);

SECTION 3. That the total number of votes cast by precinct for (YES) and against (NO) were as follows:

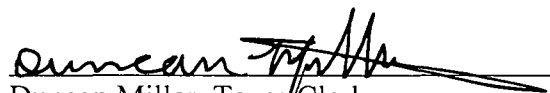

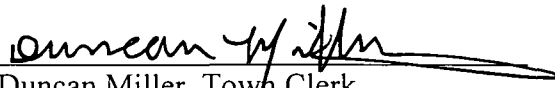
