SCOPE OF REQUEST (OVERALL)

- Request Incorporate and develop 5-acre parcel into resort
- 10 single-story guest units:
 - 2,853 sq ft 5,410 sq ft (under roof including carports)
 - 12' 14' tall
 - Private pools/hot tubs
- New one-story service building:
 - o Bar
 - Restrooms & Storage
 - 12' tall
- New perimeter walls:
 - o 8' tall




MAY 11TH COUNCIL DIRECTION

- Applicant updated site plan illustrating relocation of pools/hot tubs to east and north part of guest units
- Continued to May 25th to enable applicant to update plans:
 - Label all improvements on plans
 - Raise height of Quail Run Road wall to 8 feet tall
 - Provide cross section showing Quail Run Road wall and guest unit
 - Update plans so they match
 - Update stipulation to clarify that there shall be no amplified music or PA system at these guest units at any time

UPDATED SUBMITTAL

- Site design and stipulations to address noise concerns
- Pools/hot tubs:
 - Relocated to east and northern part of guest units
 - 85' setback from west PL and 160' setback from south PL
 - 65' setback recommended per SUP Guidelines
 - o 5' tall solid wall on west side of pool/hot tub
 - No use of pools from 10 pm 7 am
- Southern and western fence walls raised to 8' height
- Placed retention basin between guest units and Quail Run Rd fence to prevent guest from congregating in this area
- Event sound management system installed June of 2023











UPDATED CIVIL PLAN




FENCE WALL

ORD 2023-01

- Rezoning of 5-acre parcel from R-43 SFR to SUP Resort
- 2 Conditions:
 - Rezoning applies to subject property
 - Applicant shall provide executed Proposition 207 waiver form

ORD 2023-02

- Lists new and existing stipulations
- Summary of New Stipulations:
 - Improvements in substantial compliance with plans and documents
 - No lock-offs in guest units and units cannot be sold as private residences
 - Noise:
 - No amplified outdoor music or PA system
 - Pools/hot tubs cannot be used from 10 pm 7 am
 - Perimeter Fence Walls at 8' tall
 - Exterior noise monitoring system around perimeter fence walls



ORD 2023-02 (CONT.)

- Summary of New Stipulations:
 - Landscaping:
 - Planted in accordance with approved plans
 - Must be maintained and dead vegetation replaced
 - Construction:
 - Must obtain all required permits
 - Phasing as follows:
 - 1. Infrastructure
 - 2. Perimeter Fence Walls
 - 3. Improvements Guest Units, Service Bldg., Landscape, Hardscape



ORD 2023-02 (CONT.)

- Summary of New Stipulations:
 - Development agreement prohibiting sale of guest units and adding 1' VNAE along western property line



- Ordinance 2023-02: Intermediate SUP Amendment to incorporate and develop 6041 N Quail Run Road into the Andaz Resort











TWO BEDROOM VILLA







THREE BEDROOM VILLA




SITE CROSS-SECTION AT NW BUILDING










KEY MAP


