**Citizen Review & Open House Report**  
**Special Use Permit Application (SUP-15-1)**

Report on September 17, 2015 Open House

On September 17, 2015 at 6:00 PM, the Applicant, Five Star Development hosted a neighborhood open house to discuss the Special Use Permit for the Ritz-Carlton Paradise Valley ("Ritz") proposed for approximately 105 acres at the northeast corner of Mockingbird Lane and Lincoln Drive (the "Property"). Notification letters explaining the proposal and inviting citizens to attend the open house were mailed out to all property owners within 1000 feet of the Property as well as citizens on a list provided by Town staff on September 1, 2015. Approximately 25 Paradise Valley residents attended the open house. The open house sign-in sheets and comment cards submitted by residents are attached to this report.

The following is a summary of the comments received during the September 17, 2015 meeting:

- Density was discussed, and while one participant requested that density be reduced to 2.0 dwelling units per acre, other attendees understood the Statement of Direction was flexible and the 2.37 dwelling units per acre resulted in a master planned development that was better overall
- Multiple residents along Mockingbird Lane, adjacent to site, attended and were pleased with the increase to a 50 foot landscape setback for a total of 67 feet from curb to wall
- Multiple attendees were excited about the mix of uses including resort related retail
- A resident who lives across the street from the project on Mockingbird Lane attended and did not express support or opposition, but had questions about traffic and construction access. His questions were addressed and he was sent a site plan by our team as a follow-up.
- A Scottsdale resident across Scottsdale Road from the project attended and was generally supportive but had questions about views and drainage. Our team sent him a site plan as a follow-up.
- A Scottsdale resident across Scottsdale Road from the project in Sands North attended and was supportive of the project but did have questions on how it might impact views and traffic. This attendee is involved with the community's HOA and requested we speak at their October meeting. Our team is making arrangements to attend.
- Several attendees were supportive of the project and requested that the project be approved and completed as soon as possible.

- There were several attendees that were neutral and generally had questions about traffic and views.
- Several attendees requested information on purchasing residences within the plan and were anxious to see the process expedited.

The Applicant will continue to meet with adjacent neighbors, interested residents, and other parties in order to be responsive to the community's questions regarding the proposed development on the Property.
