Re: Revised Area B Alternative Plan supplemental to the submittal for the November 19, 2015 Town Council Study Session Regarding the Five Star Development/Ritz-Carlton Paradise Valley Special Use Permit (SUP 15-01)

Dear Ms. Cutro,

The purpose of this letter is to introduce the revised Ritz-Carlton SUP Area B Alternative Plan. This plan provides a number of changes which could be used for discussion at the November 19<sup>th</sup> Town Council Study Session.

This revised plan includes the following significant changes but also maintains many important aspects of the previous plan: **(1)** Reroutes the storm water wash to the south and east edges of the parcel to allow for one contiguous parcel; **(2)** new wash alignment provides for enhanced buffering of the residences from the hotel on the south and the mixed use to the east; **(3)** maintains the large lots across from Judson Estates as shown on the 66 lot Planning Commission approved plan; **(4)** the double gate system between the previous two portions of the parcel are eliminated and no longer needed; **(5)** minimum lot size is 9,000 square feet; **(6)** a total lot count of 74 lots, as a middle ground alternative to the two 66 and 80 lots plans; and **(7)** over sized "town squares" are introduced in lieu of traditional cul-de-sacs to facilitate the neighborhood pedestrian access to the public trail within the wash.

We look forward to discussing this revised Area B Alternative Plan with Town Staff and the Town Council during the upcoming study session.
