# 2. STUDY SESSION ITEMS

## 15-313 <u>Discussion of Special Use Permit Major Amendment for the Ritz Carlton</u> <u>Paradise Valley</u>

Town Manager Kevin Burke summarized changes to the site plan since the November 30 submittal. He noted that the buildings in Area A1 had been reconfigured and that the three-story elements were limited to the areas adjoining the Broadstone apartments and

the commercial retail portion of Area E.

Mr. Burke, Town Attorney Andrew Miller, and Community Development Director Eva Cutro briefed the Town Council on the Special Use Permit stipulations that were tabled during the December 3rd meeting. The applicant was represented by attorneys Jason Morris and Ben Graff of Withey Morris, Project Manager Richard Frazee and Five Star Chief Financial Officer Chris Klecka.

The Council suggested additional clarifying text that was accepted by the applicant.
