# 16-140 Update on Police Technology

Chief of Police Peter Wingert and Lieutenant Michael Cole updated the Town Council on various police technology implementation projects. Chief Wingert noted that the 2013 Public Safety Task Force report highlighted technology gaps. He detailed the Task Force's recommendations relating to technology and described the various systems that were

implemented in response. He described the one-time and annual costs, staff time needed to support the system, and whether the system has been successful.

The Council supported the Chief's plan to develop expectations and performance measures for all newly implemented technologies to determine if each technology should continue to be funded in future years.

#### 16-169 Adoption of Resolution 2016-08; Approving the FY17 Tentative Budget

Town Manager Kevin Burke presented the Tentative Budget for Fiscal Year 2016-2017. He noted that the revenue projection was \$39,463.620 and expenditures were \$49,386,133, which included use of reserve revenue for contingency and capital projects. He clarified that certain governmental fund transfers are also considered expenditures.

He explained that adoption of the tentative budget establishes the maximum authorized expenditure amount for the Town. The final budget would be scheduled for consideration on June 9, 2016. Expenditures can decrease between the tentative and final budget but they may not increase.

There was no discussion or public comment.

A motion was made by Vice Mayor Sherf, seconded by Council Member Bien-Willner, to Adopt Resolution Number 2016-08, approving the Fiscal Year 2016-2017 (FY17) Tentative Budget and schedule a public hearing on June 9, 2016 for adoption of the final budget. The motion carried by the following vote:

Director of Administration and Governmental Affairs Dawn Marie Buckland summarized Ordinance Number 2016-03.

### 16-163 Award of Community Services Funding for Fiscal Year 2015-16

Town Clerk Duncan Miller described the history of the community services funding program in Paradise Valley and the process used to solicit and review applications for funding. He said a group made up of Council Member Stanton, Council Member Bien-Willner, and Town Manager Burke met on April 28 to the review the applications.

Council Member Bien-Willner commented on this year's process and suggested changes to the application in the future including: 1) ask more directly the impact on Paradise Valley residents, and, 2) ask the organization to identify peer groups.

There were no public comments.

A motion was made by Council Member Hamway, seconded by Vice Mayor Sherf, to authorize the Town Manager to execute the following funding agreements in the total amount of \$37,000.
