

Keno Hawker

1. Briefly describe your professional experience.

Hawker and Evans Asphalt Co. Constructed and operated a liquid asphalt facility as a distributor of Chevron Asphalt Co. The facility consisted of seven tanks with 75,000 gallons of on-site storage. The company maintained and operated a fleet of seven asphalt distributor trucks and had a customer base of approximately fifty Arizona contractors. Hawker and Evans Asphalt Co. was sold in 2000 after 28 years of operations.

Hawker Manufacturing. After several years of successful operation as a distributor, Chevron Asphalt Co. closed the asphalt production portion of their Los Angeles, and Oakland California refineries. At that time I entered into a licensing agreement with Chevron to Manufacture asphalt emulsions, and tennis court paints. All of Chevrons asphalt manufacturing equipment was acquired and relocated to a newly constructed manufacturing facility in Mesa, AZ. Hawker Manufacturing was operated for 18 years and sold in 1998.

Keno's Underwater Salvage. At a young age I developed a profitable and fun side job. I established contracts with the local golf courses to retrieve the golf balls from the lakes. It was like being a child on an Easter egg hunt.. The business lasted two years and retrieved approximately 25,000 golf balls. The business was dissolved when the water quality was deemed not up to full contact standards.

2. What experience do you think qualifies you to be a Council Member?

Having served as a council member and Mayor of Mesa, I understand open meeting laws, conflict of interest, executive sessions, financial disclosure laws, and state imposed budget expenditure limitations.

I have worked well with multiple other council members, other cities and town leaders, the state legislature, Senators McCain and Flake. Also met with Moody's and Standard and Poor's prior to the issuance of municipal bond debt and was successful in getting the Cities rating improved.

I am aware of the importance of not only reading the material that staff provides, but to seek out additional information from trusted friends and experts in areas you are not proficient in. Knowing what you don't understand, and asking for help, is always better than trying to bluff your way through the discussion.

3. Please list community activities or civic involvement.

4. Please describe your experience in the following areas:

a. Public Service: Mesa City Council Member 1984-1992 and 1998-2000.

b. Hospitality / Tourism / Resort Industry. Past board member Mesa Chamber of Commerce and Mesa Convention and Visitors Bureau. Toured and negotiated with Gaylord Resort and Conference Center for their west coast location to be located east of Phoenix Mesa Gateway airport. The site was chosen and announced prior to the economic downturn, but never built.

c. Intergovernmental Relations. Past chairman MAG Regional Council . Past board member RPTA, Light Rail, & Arizona Municipal Water Assoc. Chairman, Phoenix- Mesa Gateway Airport Authority. Member Southeast Valley land fill location committee. Co-Chair of the Va Shly'Ay Akimel Core of Engineers Salt River restoration master plan with Salt River Pima Maricopa Indian Community.

d. Budget / Finance. During my term as Mayor of Mesa one of my goals was to create a 25 year build out master plan for the city that was paired with a matching 25 year financial forecast. The model is still being used today.

Mesa knew its build out boundaries 135 sq miles, and estimated 2035 population 650,000. The task was to match the projected build out population with a job's to housing ratio at or above the regional average.

Several insights were evident after a careful evaluation of Mesa's financial condition. First was the heavy dependence on sales tax and utility revenue as the major funding source for Mesa . It should be noted that Mesa had a fifty year history of operating without a municipal property tax. Another important discovery was the importance of calculating the true cost of municipal employees , not just current wages, but long term medical and pension costs. Copies of the final report are available on the City of Mesa web site

e. Development / Contract Negotiations. Negotiated the contract, and hired the existing City Manager of Mesa, Chris Brady. Also directly advertised, interviewed and hired the Chief Magistrate for the City of Mesa Municipal Court, Judge Matias Tafoya, and the Mesa City Attorney Deborah Spinner each with council concurrence. Have analyzed and voted on numerous RFP for redevelopment projects in downtown Mesa, and new commercial development in and around Falcon Field, and Phoenix Mesa Gateway Airport.

f. Storm water and Drainage Management . No experience in this area beyond building parking lots with adequate on site retention.

Please submit written responses to the following questions.

1. In your opinion, what are the biggest challenges facing Paradise Valley and how would you address them?

Revenue dependence on traffic enforcement, and resort revenue. The immediate future looks good, but I have concerns about the AZ State legislator prohibiting photo radar, and the hospitality industries ability to withstand an economic downturn. One solution would be the creation of a rainy day fund sufficient to allow time to implement budget adjustments.

Storm Water run-off. I don't have any suggestions currently, but I would like to see what the city engineers are recommending and would like to learn more in this area.

Sewer system vs. septic tanks. I appreciate how expensive a full sewer system would be for the Town of Paradise Valley, but I still believe that the Town should work towards that end.

Traffic. I would not recommend building additional lanes on Major Arterials as that would just encourage additional drive thru traffic. I would consider merging lanes to exit side streets. If a house is a full tear down, on the corner of a major arterial and side street, I would support a fund to purchase additional ROW for a turning traffic lane.

Mountain side development. I see a bright future for Paradise Valley if it continues to focus on high end resort, and one acre minimum housing sites. The town's unique setting with both Camelback and Mummy Mountains as part of the view corridor needs to be protected. When additional houses are permitted and developed on the face of the mountains, they must be accessed by a roadway that does not create a visible scar.

Cell reception. I am in favor of creating better cell reception, but not by creating towers on the mountains. I would favor a continuation of the existing non intrusive cell construction program.

1. In your opinion, what are the biggest challenges facing Paradise Valley and how would you address them?

Two items are of particular interest to me. The first is the issue of flood control. I believe that my experience and knowledge gained by serving on the Flood Control District of Maricopa County for nearly 20 years will serve the Town well as it attempts to address both local and regional drainage issues. One of my first accomplishments in this area was the construction of the flood related improvements along Doubletree Road. Undoubtedly there are many other improvements needed in this area and I am confident that I would be able to use my past experience to benefit the Town in its efforts to prepare for and deal with flood related issues in the future.

The other issue I would like to help resolve is the underfunded pension problem. I would use knowledge and experience I gained from my time on the Board of Supervisors to help the Town find the solution to this critical issue facing nearly every local government. I have come to the conclusion that most threats to local government authority emanate from the state legislature. I do have substantial experience working within the legislative system and am eager to use my experience to help the town.

Biggest challenges facing Paradise Valley

1. Potential loss of sales tax revenues if legislature changes tax collection methodology to the point of sale of the construction materials. Addressing this major issue requires ongoing, continued lobbying of elected officials and providing them with tools including compelling facts why this would significantly hurt our Town and propose alternatives that would be more fair.
2. Adequate money to properly fund the Town's ongoing capital needs to maintain our infrastructure. This is best addressed by fully understanding and prioritizing the town's needs and annually updating rolling five and 10 year capital plans. Since capital spending is very visible to our residents and helps support our "brand" it must remain a high priority and not fall into a category of spending "what's left ". With our new resorts coming online, money should be available for funding capital needs thus, the challenge is for the Town to remain prudent/diligent in its allocation of capital.
3. Resolving Storm Water Drainage issues is another big challenge for the Town. Our current funding of studies covering various parts of the Town serves to identify the extent of the problems and costs we are facing. Next is working with local and national agencies to find funding to help mitigate the issues. Since finding funding is a long term process, the Town must keep Town residents fully informed as to what we are doing while also assisting individual homeowners in ways they can protect their homes.

I have the time, ability, and high desire to continue to serve the residents of Paradise Valley.

Background Information

In this position, I manage ~\$2b expenditure for production materials, corporate services, capital equipment, facilities, and other purchases; leading a global team of over 250 procurement, supply chain and quality professionals. Previously I global sourcing and supply chain executive at major aerospace company; owned and operated a global supply chain consulting company; was vice president and general manager of major tier one automotive supplier; and various positions of increasing responsibility in industrial and manufacturing industry.
2. I have served as planning commissioner for the Town of Paradise Valley for the past 3 years, and prior planning commissioner for Park Township MI and Ottawa County Michigan. I am currently Trustee of Arizona State University, member of the WP Carey School of Business Dean's Council, and Co-chair of the ASU foundation president's club. In the past I have run for Township supervisor and 2nd congressional district representative (primary).

Written Responses:

1. Among the biggest challenges facing Paradise Valley is the resident unwillingness, and the council's inability to maintain fidelity to the general plan vision, requirements and town structure. Virtually every development application presented to the town provides justification as to why variance from the general plan should be made. Based on the growth and investment opportunity, the council typically approves these plans (with planning commission support). The continuation of this course of action will create a pattern of development and establish precedent that will permanently change the character of the Town. I believe the solution to this problem is to have developed a more clearly defined set of operating rules which shape the Council statement of direction to the planning commission under which exceptions should be considered. Additionally, applications that are significantly out of compliance to the general plan should be rejected as inconsistent with Town objectives and/or requiring a higher level of substantiation before processing. Finally, there should be greater engagement of citizen planners outside of construction and development as to avoid narrow perspective on the nature of development in the Town.
