- 1. Promoting resident participation and engagement
- 2. Engaging the community on public safety issues
- 3. Receiving presentations and materials from the Paradise Valley Police Department
- 4. Advising the Mayor and Town Council on Committee activities and recommendations

Please answer the following questions, keeping the response to less than 1000 words total, not for each question. Please return the completed questionnaire to Town Clerk Duncan Miller at dmiller@paradisevalleyaz.gov by Friday, March 3, 2017 at 5:00pm. The current ACOPS members will review your answers to these questions and make a decision on who should be interviewed for the ACOPS vacancy. Interviews will take place on March 14, 2017 during the evening hours.

- 1. How did you learn about the vacancy on ACOPS?
 - a. I received a call from a friend that is also a town resident letting me know of the opportunity to serve. I have been interested in finding a way to serve in our community which I have enjoyed for more than 22 years.
- 2. What are the top two or three items you would like to see ACOPS address or continue to do in PV?
 - a. The PVPD Strategic Plan sets forth several effective tactics and programs for encouraging community empowerment that have yet to be implemented. I believe ACOPs can work effectively with the PVPD to assist in the implementation of several key elements. The programs referenced in the Plan such as Citizens Police Academy, the Youth Police Academy and the proposed non-profit foundation are effective parts of community policing at the state local and federal levels used throughout the world. As a graduate of the FBI's Citizen Academy program, I became a member of the non-profit alumni association, which has the mission of encouraging graduates to remain involved and up to date on key issues facing federal law enforcement. The alumni association also serves the same purpose as the proposed Police Foundation, funds itself, and supplements outreach efforts with tax-exempt donations from the community. I believe this could be extremely effective in the Town.

Since graduating, I have volunteered for more than 10 years with the FBI at the state and national level in the leadership of these programs. I currently serve as the SVP (Second in Command) of their FBI National Citizens Academy Alumni Association that oversees and assists with their Citizens Academy programs at each Field Office and the 60 Alumni

Association Chapters throughout the nation. I have helped at every stage in forming, managing, operating and administering these Citizens Academy organizations to ensure their alignment with law enforcement objectives and encourage continuing engagement. Each separate organization has a memorandum of understanding (MOU) with their support field office outlining roles and responsibilities to ensure clarity and prevent confusion in roles.

In short, I believe the experience garnered over the past decade will be of help to our community as we move forward in rolling out these programs. ACOPS provides a means for the community to partner with the PVPD in achieving these objectives.

- 3. What are your suggestions to help ACOPS with effective education, outreach, and enhancement of security?
 - a. As an example, last year I assisted in putting together a partnership between the PVPD and the FBI's Cyber Division to provide education to Town residents on cybercrime and online fraud. The goal of the program was to develop community awareness and help residents improve their security posture. This is intended to be the first in a series of community discussions on the topic. Fraud and cybercrimes are likely the largest unreported source of crime experienced by town residents and a source of fear. I believe ACOPS can work with the PVPD in bringing other businesses and partners to increase awareness, reduce crime, and provide education to help residents better protect themselves in all areas.
