



TOWN COUNCIL MEETING 6401 E. LINCOLN DRIVE PARADISE VALLEY, ARIZONA 85253 MINUTES Thursday, March 9, 2017

1. CALL TO ORDER / ROLL CALL

Mayor Collins called to order the Town Council Meeting for Thursday, March 9, 2017 at 4:00 p.m. in the Town Hall Boardroom.

2. STUDY SESSION ITEMS

17-074 Discussion of a Proposed Lot Split 6912 E Horseshoe Road

Senior Planner Paul Michaud presented a request by the Sharma Family Trust to split a 2.4-acre parcel into two lots. The site was located at 6912 E Horseshoe Rd. He reported that the properties would meet all requirements for R-43-zoned lots. He said that it is located in Berneil Water district and is designated as a low pressure area. He reported that there had been no public comment. He stated that the Planning Commission voted unanimously to recommend approval, subject to four stipulations.

He said the proposed lot split was scheduled for Council action on March 23, 2017.

17-082 FY 2018 Budget Overview and Capital Improvement Program

Town Manager Kevin Burke and Director of Administration and Government Affairs Dawn Marie Buckland briefed the Town Council on the economic forecasts, methodologies, and local conditions that would be used to develop the Fiscal Year 2017-2018 Budget. Ms. Buckland highlighted that in FY 2018, the fund balance was projected to be 107% of operating expenses. Should the Council wish to continue accelerated payments of \$5 million annually to retire the Public Safety Pension liability, the debt would be paid off in three years. She said early payoff would save approximately \$9 million. The financial impact would reduce the fund balance to a low of 53% of operating expenses in FY 2020. The fund would grow back to 90% by FY 2028.

Mr. Burke noted that the ten year forecast includes \$5 million a year in capital projects funding, an ongoing budget for vehicle replacement and facilities maintenance, Lincoln Drive and Tatum Blvd resurfacing, and the option for the Council to reduce the Fire Service Fee by 10%. He stated that he would be asking the Council for additional staffing - mostly in the Police Department. He said he is also considering switching health insurance providers to reduce costs.

Engineering Services Analyst Jeremy Knapp summarized each of the projects in the five-year capital projects program. The Council identified projects to cut and requested additional information on others prior to making funding decisions. The Council stressed the importance of coordinating planned street and sidewalk projects with the pending Visually Significant Corridors Master Plan, the Bicycle Pedestrian Master Plan, and any potential drainage improvements.

Mayor Collins recessed the meeting at 6:00 p.m.

17-083 Interview of Applicants and Appointments to the Planning Commission

Mayor Collins stated that two vacancies on the Planning Commission that must be filled. Commissioners Tom Campbell and Rick Marhle submitted letters asking to be reappointed. Commissioner Jeff Wincel asked not to be reappointed. Former Commissioner Scott Moore was elected to Council thus creating the second vacancy.

The Mayor and Town Council interviewed Ellen Andeen, Alec McAusland, James Anton, Nadia Bashir, Charles Covington, Rick Johnson, Priti Kaur, and John Vargas. The Council discussed and ranked the applicants.

A motion was made by Council Member Pace, seconded by Council Member Moore, to reappoint Richard Mahrle and Thomas Campbell to three-year terms, appoint James Anton to a three-year term, and appoint Charles Covington to a two-year term on the Planning Commission effective April 1. The motion carried by the following vote:
