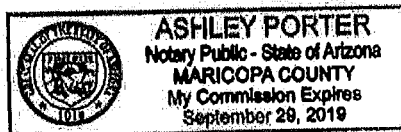

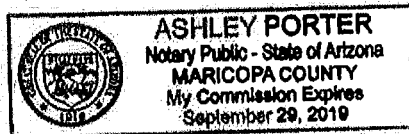

PUBLIC HEARING NOTICE

Dear Resident:

Wendy Riddell of Berry Riddell L.L.C., on behalf of Christ Church of the Ascension, has filed a Minor Amendment application to the Special Use Permit on the Christ Church of the Ascension property located at 4015 E Lincoln Drive (Assessor Parcel 169-22-076B) to allow for 5th grade. Presently the school on the church property can have pre-school up to 4th grade, not to exceed a total of 168 students and not to exceed more than 14 students in 1st, 2nd, 3rd, and 4th grades. The proposed amendment seeks to modify the existing stipulation related to the allowable curriculum on the property to add 5th grade; with not more than 14 students in 5th grade, no change to the maximum 168 student enrollment, and no physical changes to any structures.
