Paul, with all due respect.

I am a successful serial entrepreneur also, have been a corporate entity leader in various roles, and have had the opportunity to be in the trenches of a large company service contracting team.

The HOA you are a member of negotiated or bid for a special dedicated service contract for its residents and the result was excellent. Why shouldn't the Town do the same for all the residents?

How many residential locations are there in your HOA? How many are there in the Town? One could argue that your HOA is currently being subsidized by the rest of the residents that use your hauler? This is a slippery slope discussion because it can appear you want to keep a benefit for a few but deny it to the rest of the town. But I can understand the problem you are pointing out and the negative energy it can bring.

Perhaps the contract management process RFP should have included a requirement to address the special negotiated prices for full HOAs? At this point it may be too late for the RFP process to be improved, however it could be re-bid because it our town process, we own it, we drive it, but there is no rule that precludes negotiating a best and final deal that includes your HOA contract as it stands, and future RFPs to include more efficient HOA situations be treated properly. I think the supplier/vendor is just trying to maximize its profits and there certainly is room for them to honor the existing 100% participation HOA contracts.

I have no access to the details of the offers or the RFP requirements, and have not been involved in any way. I have no conflict of interest other than that I am resident. However I can assert that the definition of the RFP requirements is the most important part of the process as it must include the requirements of all the stakeholders. If all the stake holders' requirements are not in the RFP then an examination of how the RFP requirements were built requires analysis and evaluation.

Nevertheless, I believe that the significant objection you bring up is a valid one and can be addressed with the vendor/supplier before contracting. They will bend. There is a mutually agreeable solution. I think this problem requires tougher negotiation in this managed free market process, if the RFP is not re-issued.

I'd have to explain to my HOA members, and several other HOA members throughout the Town, why their costs were going up by 60% for the same services. I can't think of how I'd say that with a straight face.

Our Town does not have a property tax so it would not be saving the residents any money. The 'savings' from less wear and tear on the roads is, at best, a guesstimate. The having only on truck on the street would be a nice benefit, I totally agree!

The amount of residents who believe they can select a better vendor than the government is outweighing those who think one is a better idea. As an elected official, I'm not voting against what my residents want by such a large margin and something that will help some and hurt others.

I'm also a serial entrepreneur. I'm on the global board of the Entrepreneurs Organization. In my experience government picking winners and losers is usually a bad idea and certainly is against the concept of limited government that our Town espouses. Our Town if filled with successful folks who achieved their financial independence by being entrepreneurs.

To my fellow town residents and honorable council members:

I would like to make a short statement to the council members in support of the process that has been undertaken to add professional supply/vendor management processes to improve all aspects of how trash hauling is carried out in Paradise Valley. It is clear to me that the effort can be a win-win for all stakeholders concerned. The quality of the result will be directly related to the competitive nature of the process, which pits the qualified relevant trash hauling companies against each other in a capitalist free-for-all bid process, with prudent rational requirements in the Request for Proposal. These limits and requirements were used to create the best results for the town and its residents.

The future satisfaction of the residents will hinge in part on the professional management and quality control to be managed by the town staff contract administration. By measuring service quality with feedback from residents, service problems should be resolved with the selected supplier working towards meeting the objectives set out in the contract. Quality control can be maximized by including the residents in a quality survey periodically, amongst other methods you can define. If the supplier fails to deliver its promises, then a new RFP should be issued and the contract cancelled for non-performance.

The bid process is designed to make the contracting of the service as cost efficient as possible by the mere inclusion of all the trash haulers in the process to compete directly with each other, and by causing them to figure out the best, most efficient manner of gathering the trash with a vastly superior volume of business than if split into 5 different haulers. In fact its possible for the account to be more profitable than ever for the hauler that wins the contract, while at the same time making the cost to the individual homeowner less expensive or more service rich. Apparently these objectives are being met.

I am confident the town residents will gain lower prices and better quality of life as a result of the

process. The minimum service levels must always be spelled out in the RFPs, and subsequently in the service contracts, to give the residents the service choices they require. Clear conflict-of-interest policies and ethics policies must be in place and enforced for the town contract management team. This effort does create additional responsibilities for the PV town staff, a challenge I am sure they can execute professionally and capably, along with the active oversight of the mayor and town council members.



Mayor and Council (listed in the BC line):

I see you all received this email. This does not appear to be a protest but rather “to help further educate.” So I will respond just to Council and staff at this time. A protest has some more formal procedures that they and the Town would need to follow.

As you know, RAD ranked second with its proposal. Under our procurement process, if the Town reaches an impasse with its top ranked proposer(Republic), it can declare that impasse and move to the next highest ranked proposer and begin negotiations with them. Or the Town can reject all proposals and either start over or not solicit again. So all options.

To their points, both in the email and in the attached letter. First, RAD is absolutely right, Republic is not the lowest priced proposal. RAD knows this because their proposal had a lower price. In fact (and RAD does not know this until we release all of the proposals after a contract has been awarded or the proposals have been rejected), they were the lowest of the 4 proposals received. As such, if you looked at just the scoring for pricing, RAD was rated number one by all 5 evaluators. But, as you also know, pricing is only 30% of the scoring. RAD did not do as well in other categories. But in part because they

had the best pricing, and the fact that they had decent scores in other categories, the ranked number 2 in the overall scoring.

To the second point, I am not sure how they calculated the savings and even if they are right, it doesn't change the fact that this is not a low bid procurement.

To the last point, I understand what they are saying, but it doesn't change the outcome. By that I mean. Republic was not scored based upon their pricing for a 7 year contract. All scoring was based upon the 3 and 5 year proposals. The seven year is a subsequent negotiation. Second, as previously noted, RAD already had the lowest proposal so they already were the top scorer. So it doesn't change their rank if they were able to offer an even lower priced 7 year contract.

What this information tells you is that there could be a lower price out there, but that lower price might come at the expense of lesser customer service, less financial strength of the firm, less experience, etc. Again, ranking of these proposals was based upon multiple factors.

So this is what I will answer if this comes up in public meeting.

Dear Mayor and Town Council,

I'm providing this letter to inform Town Council and Staff of my concerns with the current RFP process regarding the solid waste and recycle collection services in Paradise Valley. I have been in the waste industry for over 17 years, it's my belief that Town Staff and Council are moving in the right direction in a one-company service provider for the residents of Paradise Valley. The pros greatly outweigh the cons with this type of transition.

However, the core reason for contacting Town Council is the Town Staff's intent to reach an agreement with Republic Services.

Presented by Kevin Burke, Town Manager, at the Study Session on December 7<sup>th</sup>, the following three subjects, outlined below, are vital concerns, which may be questioned from the community or other individuals:

- The price presented by Republic Services **is not the lowest** presented
- If awarded to Republic Services, the residents of Paradise Valley will **pay \$1,853,823.19 or more** over the next 10 years

- Outlined on Form 7, within the Paradise Valley Solid and Recycling Waste RFP, all bidders were directed to propose a “Basic and Standard Service” of three (3) years and five (5) year terms. The seven (7) year, with three (3) one (1) year renewals, offered only to Republic Services, created a substantial disadvantage to all other bidders.

To help further educate and understand these concerns we have attached the formal outline (PDF) for your review. We trust this information will be instrumental in creating a fair and nonbiased outcome that is truly beneficial to the residents of the Town of Paradise Valley.

Scott appropriately asked that I share the information below from Fountain hills and my response. Thanks

Scott,  
I did not have this specific information. I had a general idea of their rates from an earlier conversation with Paul Mood when he first transitioned because he gave us the ballpark he remembered from when Fountain Hills made the switch. I went into the rfp with similar expectations.

When we did not get it, I looked and asked a number of questions. First, I looked at all the other RFP's. These are sealed bid amongst very fervent competitors. The lowest 3 year rate amongst the four was \$17.40per month. So that gave me a pretty good idea of what our market was. Now I went back and looked at the 5 year rates, the lowest 5 year rate was \$16.50. But remember that price is only 30% of the scoring. Even so, I tried to get that Matched. The response was no.

I then talked to queen creek, buckeye and lake havasu about their rates which were all lower. In all cases they have many more accounts than we do. Fountain hills has about double the number of accounts. Lake havasu was more but they also were at 15-20 year Agreement. Buckeye obviously has far more accounts, but they and queen creek were doing their own billing. So that saved an estimated \$1per month per account.

Lastly, I argued that there is already lower rates in town as evidenced by the hoa's with fewer accounts. How could that be possible? The answer I got was these are not hillside accounts. A small flatland subdivision with close driveways is much easier. These rates account for the wide variety of accounts across PV.

So again, I argued for lower rates right to the last day under the guise that it's an easier story line if they can say they have a \$16 rate. They insisted they could not go any lower. I told them that I thought it would be a hard sell for Council but they said they were willing to take their chances.

Remember, if the issue is price. You can turn down this proposal and I can go to the next vendor on the list. And I told Republic this as well. So that continues to be a backup.

Dear Councilman Dembo,  
Thank you for your quick response.

I find it odd that an HOA is getting significantly lower rates than the entire town, unless they are using dumpsters, or a lower level of service. The economy of scale should have brought that into some alignment, unless the competing companies shared information (which is a crime), or they make more profit with the system in place today even without 100% of the households . What company does your HOA use? Did they bid on the entire town?

To date I was unaware of the pricing that the town negotiated... it doesn't sound like we did very good. For your reference, I have Republic Waste today with twice per week trash and once per week recycle. My single annual payment was \$334.72 or \$27.89/month for the last two years, and my annual renewal invoice just came in at \$350.41 or 29.20/month (4.7% increase). I was hoping that not having multiple trucks running into town would have a more significant impact on pricing than you mentioned below. I hope they plan to offer a discount for people willing to make a single annual payment like we do with the Fire service. I will contact Republic from my side to voice concern that the economic impact is minimal for me personally, and that I expected more.

Has the town thought of allowing HOAs with a minimum number of homes to opt out as long as they have a single provider that meets whatever requirements the town has put on the main supplier regarding frequency and equipment?

It doesn't sound like this debate is over, but I hope in the end we get to a situation where a single provider is possible at least by area of town.

The amount of residents who believe they can select a better vendor than the government is outweighing those who think one is a better idea. As an elected official, I'm not voting against what my residents want by such a large margin and something that will help some and hurt others.

Unless things change with the RFP or numbers, we will disagree on this matter. If things change... I can change my opinion too.
