

## **RESOLUTION NUMBER 2018-03**

### **A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PARADISE VALLEY, ARIZONA, (“TOWN”) AUTHORIZING THE TOWN MANAGER TO EXECUTE A LICENSE AGREEMENT WITH ALLIED WASTE TRANSPORTATION INC., AN INDIRECTLY-OWNED SUBSIDIARY OF REPUBLIC SERVICES, INC. FOR RESIDENTIAL SOLID WASTE, RECYCLING, AND DISPOSAL SERVICES**

**WHEREAS**, pursuant to Section 8-3-2(F) of the Paradise Valley Town Code, the Town, acting through the Council, “reserves the right to limit the number of licenses granted” to solid waste collection contractors; and

**WHEREAS**, the Town desires to improve the quality of life for its residents by reducing the frequency of solid waste collection vehicle trips, reducing the wear and tear on Town streets, reducing noise and pollution impacts from the solid waste trucks, and maintaining or improving solid waste collection service delivery; and

**WHEREAS**, the Town issued a Request for Proposal (RFP) on July 6, 2017 for a single contractor to provide residential solid waste, recycling, specialty waste collection, and disposal services; and

**WHEREAS**, the Town negotiated a license agreement with the contractor determined to have submitted the proposal most advantageous to the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PARADISE VALLEY, ARIZONA, AS FOLLOWS:**

**SECTION 1.** Acting pursuant to the powers specified in Section 8-3-2(F) of the Town Code, the Council has determined, for the reasons stated herein, to exercise its power and limit the number of licensed solid waste contractors to one such contractor, that is, Allied Waste Transportation Inc., an Indirectly-Owned Subsidiary of Republic Services, Inc. (the “Licensee”).

**SECTION 2.** The contract with the Licensee attached hereto as Exhibit A is hereby approved by the Council and shall take effect on July 1, 2018.

**SECTION 3.** Pursuant to Section 8-3-2(F), effective July 1, 2018 no other licenses shall be issued, save and except for the license granted to the Licensee pursuant to the terms of the License Agreement including conditional licenses for those completing contract obligations under the Most Favored Nation clause, and no other license applications will be accepted.
