1. CALL TO ORDER / ROLL CALL

Vice Mayor Bien-Willner called to order the Town Council Meeting for Thursday, March 8, 2018 at 3:00 p.m. in the Town Hall Boardroom.

2. STUDY SESSION ITEMS

18-083 Discussion of Storm Drainage Design Manual Policy

Town Engineer Paul Mood and Engineering Services Analyst Jeremy Knapp presented the draft Storm Drainage Design Manual. The Council discussed finding the right balance between preserving a natural wash and maximizing the value of the property. Staff was directed to organize a charrette with various examples of properties with washes and invite builders and residents to comment.

There was consent for Council Member Moore to meet with staff separately to incorporate his edits.

18-113 Discussion Regarding Amending §11-2-30 of the Town Code - prohibiting parking on visible areas of residential property

Town Attorney Andrew Miller presented a proposed ordinance regulating parking on residential property. There was not support to proceed with the ordinance as drafted. Mr. Miller was asked to redraft the ordinance to specifically address parking at properties with home occupations, which include short-term rental properties.

18-114 Discussion Regarding Amending Article 6-2 of the Town Code and §6-9-7 of the Town Code - procedures for plats and lot splits

Mr. Miller presented an ordinance amending the approval process for plats and lots splits. The Council directed staff to amend the draft ordinance to provide that lot splits and final plats would still be present to the Council but they could be placed on the consent agenda and not require a study session prior to approval.

18-110 Discussion Regarding Amending §15-2-12 of the Town Code to Allow for the Discharge of Swimming Pool Water into the Sewer System

Mr. Miller presented a draft ordinance allowing residents to discharge swimming pool water into the sewer system. This practice is currently prohibited by Town Code because of sewer capacity restrictions under the previous intergovernmental agreement (IGA) between the Town and the City of Scottsdale. When the IGA was amended, the volume restrictions were removed. It was noted that residents on septic should not discharge pool water into their septic system. Moreover, residents may not drain chlorinated pool water into a wash or drain chlorinated or non-chlorinated water into the street.

There was Council consensus to schedule the ordinance for a vote. Council directed staff to develop a strategy to educate residents on the new requirements.

18-107 Discussion of Community Services Funding

Town Clerk Duncan Miller presented the following options for implementing the community Services funding program for FY 2017-18: invite proposals for funding; conduct a community needs assessment; fund a specific agency or program identified by Council; or do not appropriate the budgeted funds this year. The Council directed staff to invite grant funding applications. Council Member Pace and Council Member Sherf were assigned to advise the Town Manager on his funding recommendations to Council.

18-103 Legislative Update

Deputy Town Manager Dawn Marie Buckland updated the Council on legislation of interest to the Town including photo enforcement, zoning regulations for private schools, and signs in the right-of-way.

Maintenance Program to M.R. Tanner in the amount of

Crack seal and apply Polymer Modified Master Seal (PMM) in Maintenance District 14 and Mockingbird Lane from Invergordon Road to 56th Street. The motion carried by the following vote:

18-109 Authorize the Town Manager to enter into a contract with Arizona

Trench Company for trenching, installation of underground conduits, pull boxes and equipment pads for District 30 Overhead to Underground Conversion Project in an amount of \$659,196 and authorize payment of \$159,757 to Arizona Public Service and \$113,286.63 to CenturyLink upon completion of District 30 in Fiscal Year 2019 and authorize a budget transfer from FY2017-18 CIP Project 2016-14.1 Lincoln Drive - Ritz Related Roadway Improvements to CIP Project 2016-02 APS District 30 to fund the town's portion of the project.

Engineering Services Analyst Jeremy Knapp presented a contract and budget transfer to underground APS utility conversion district 30.

Scottsdale resident Charles Lotzar spoke in favor of the project. Joe Kelly did not speak but submitted a comment card supporting the project.
