3. STUDY SESSION ITEMS

18-278 Discussion of Town Manager Recruitment and Organizational Planning

Mayor Collins reconvened the Study Session at 5:25 PM.

Mayor Collins explained that, following Mr. Burke's resignation, the Town retained Interim Public Management (IPM), a local firm specializing in providing temporary public sector executive level staff for communities across Arizona. The Town used this firm in the past to hire the interim director of public safety.

He announced that IPM provided the Council with three candidates who will be interviewed between now and the end of the month. The Council will appoint an interim manager at a special meeting on August 2 with a start date of August 6. This will provide some overlap before Mr. Burke's last day on August 11. The interim candidates were: Ken Buchanan, Brian Dalke, and Cynthia Seelhammer.

Vice Mayor Bien-Willner explained the process that would be followed to hire a new Town Manager. He stated that the Town contracted with CPS HR Consulting to conduct a nation-wide recruitment. The Town used CPS to employ previous Town Managers Jim Bacon and Kevin Burke. He said a Special Meeting will be held on July 19 with CPS to discuss expectations, benchmarks, and timelines. It is anticipated that the recruitment process will be concluded by the end of December.
