18-293 Discussion of Town Manager Recruitment

Josh Jones, Executive Recruiter with CPS HR Consulting, met with the Mayor and Town Council to discuss the Town Manager Recruitment process, expectations, and timeline. Key milestones included the development and distribution of the recruitment brochure with a release date of July 30. The anticipated filing deadline was August 31. Candidate screening and review would be completed by mid-September. Candidate interviews would be held the first week of October. The goal was to employ a manager by the end of the calendar year.

The Council provided feedback on the recruitment brochure and briefly discussed the qualities of an ideal candidate. It was agreed that all comments should be submitted to Vice Mayor Bien-Willner and Mr. Jones by the following Monday.
