18-303 Authorize the Town Manager to Execute a Scope of Services Agreement with IPM and Appointment of an Interim Town Manager

Mayor Collins announced that the Town Council discussed the finalists for the position of Interim Town Manager and were prepared to make an offer. The Attorney was asked to prepare amendments to the proposed scope of services schedule consistent with the direction provided during the executive session. It was the Council's preference that the scope of services schedule be executed as soon as possible so that the interim manager could start work on Monday, August 6, 2018. This would enable a one-week overlap with Town Manager Kevin Burke.

A motion was made by Council Member Dembow, seconded by Council Member Moore, to authorize the Town Manager to execute a scope of services schedule for interim town manager services with IPM. Furthermore, that Brian Dalke be appointed to the position of Interim Town Manager effective August 12, 2018, subject to the completion of a mutually acceptable contract and authorize staff to take all actions necessary to complete the transition.
