

### **SCOPE OF PROJECTS**


- Reconstruct roadways: Lincoln Dr, Mockingbird Ln and Indian Bend Rd
- Traffic signals on Lincoln Dr at Mockingbird Ln and at Quail Run Rd (new)
- Roundabouts on Mockingbird Ln at: Indian Bend Rd, Cheney Dr, and Northern Ave
- Sewer and storm drain upgrade (10-year storm event)
- Utility relocations
- Meandering sidewalks
- Bike lanes: Mockingbird Ln and Indian Bend Rd
- Landscaping within right of way and medians




#### **General Plan 2012**

**Collector (Indian Bend Rd): Serve interior streets** 





#### GATEWAYS + FOCUS AREAS Gateways




Figure 2.2: Gateway Locations

To aid in evoking a sense of arrival, gateways have been identified for each of the four major entrances into the Town indicated on *Figure 2.2* below. These gateways should include the following:

#### **Threshold Paving**

 A visual and tactile component such as the use of rustic pavers at the gateway, which transition into rubberized asphalt to create a brief change in driver awareness of crossing a threshold into the Town.

#### **Visual Traffic Calming**

 Visual narrowing of the road through the use of roadside enhancements and landscaped medians that encourage vehicle users to slow down to the 40 MPH posted speed limit on the two identified Visually Significant Corridors.


#### **Enhanced Streetscape**


- Pedestrian and bike friendly entry into Town, with lush desert landscape selected from the appropriate Character Zone plant list.
- Placement of the standard Town of Paradise Valley entry sign within the landscaped enhancements.















#### 2015 Development Agreement (Five Star Development)

- Construct Lincoln Dr to Visually Significant Corridor Standards
- Right hand turn lane WB Lincoln Dr to NB Palmeraie Blvd
- Right hand turn lane WB Lincoln Dr to NB Mockingbird Ln
- Left hand turn lane in each direction at Quail Run Rd
- Traffic signal on Lincoln Dr at Quail Run Rd
- Modify Lincoln Dr medians
- Install Town entry sign on Lincoln Dr








- Lincoln Dr: Extensive utility work, paving, and medians
- Mockingbird Ln: Storm drain, water lines (City of Phoenix & Epcor), paving, and traffic calming
- Indian Bend Rd: Storm Drain, paving, and traffic calming

- Decision points:
  - 1. Limit traffic impact on daily basis for longer duration and greater cost
  - 2. Extend working hours/increase short-term impact for shorter duration and lower cost





# Roadway Improvement Related to Ritz-Carlton Resort - Lincoln, Mockingbird & Indian Bend

#### Roadway Improvements Related to the Ritz Carlton Resort - Lincoln, Mockingbird & Indian Bend

The town is currently at the 30% design stage to reconstruct several miles of roadway near the proposed Ritz Carlton Resort. The roadways include Lincoln Drive between Scottsdale Road and Mockingbird Lane, Indian Bend between Scottsdale Road and Mockingbird Lane, and Mockingbird Lane from Lincoln Drive to Northern Avenue. These improvements to the roadways include paving, curbing, medians, sidewalks, bike lanes, landscaping and storm water improvements. A traffic signal will be constructed at the intersection of Lincoln Drive and Quail Run Road as well as a roundabout at Mockingbird Lane and Indian Bend Road. More information regarding this project will be available as it progresses.
