



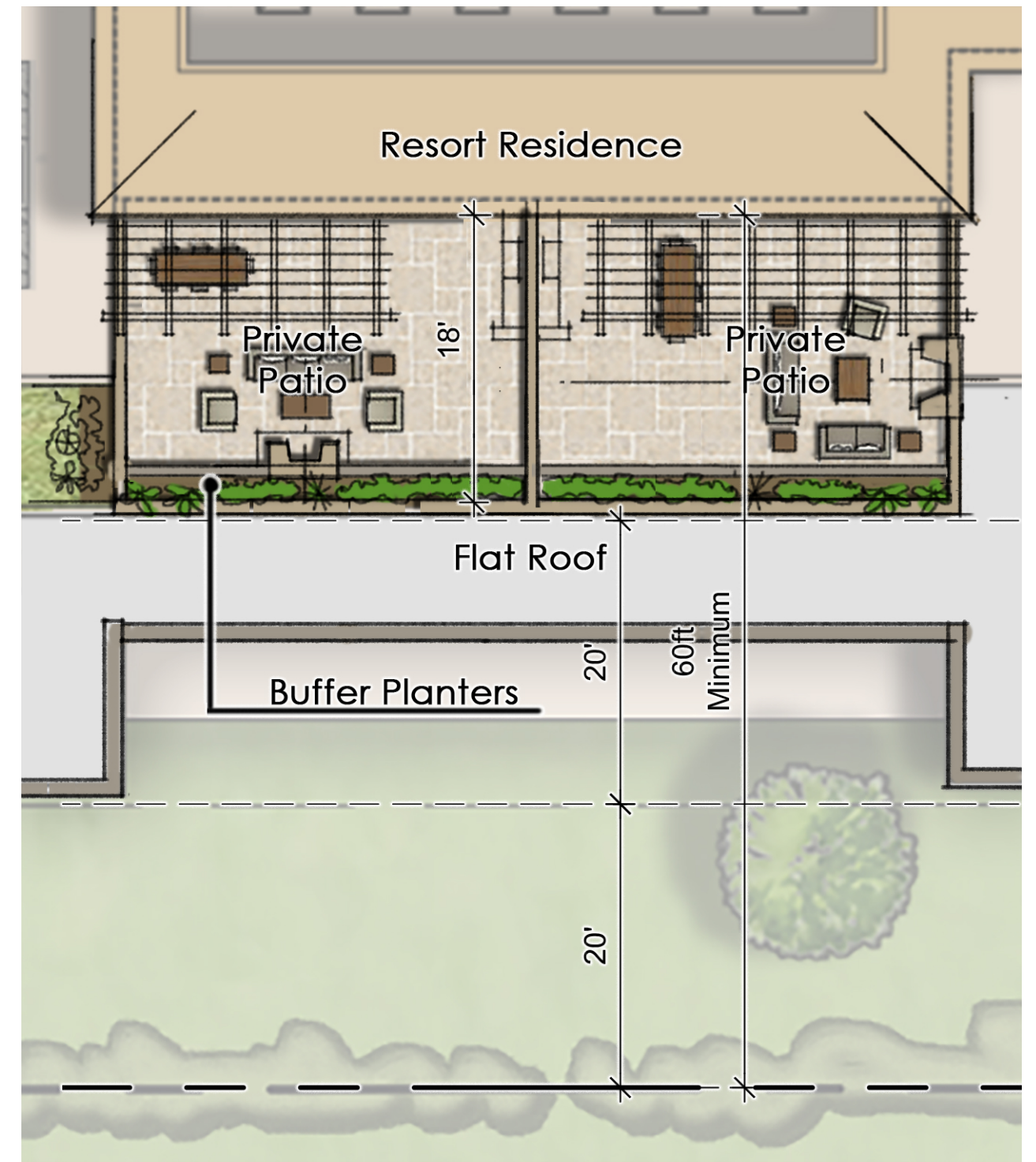
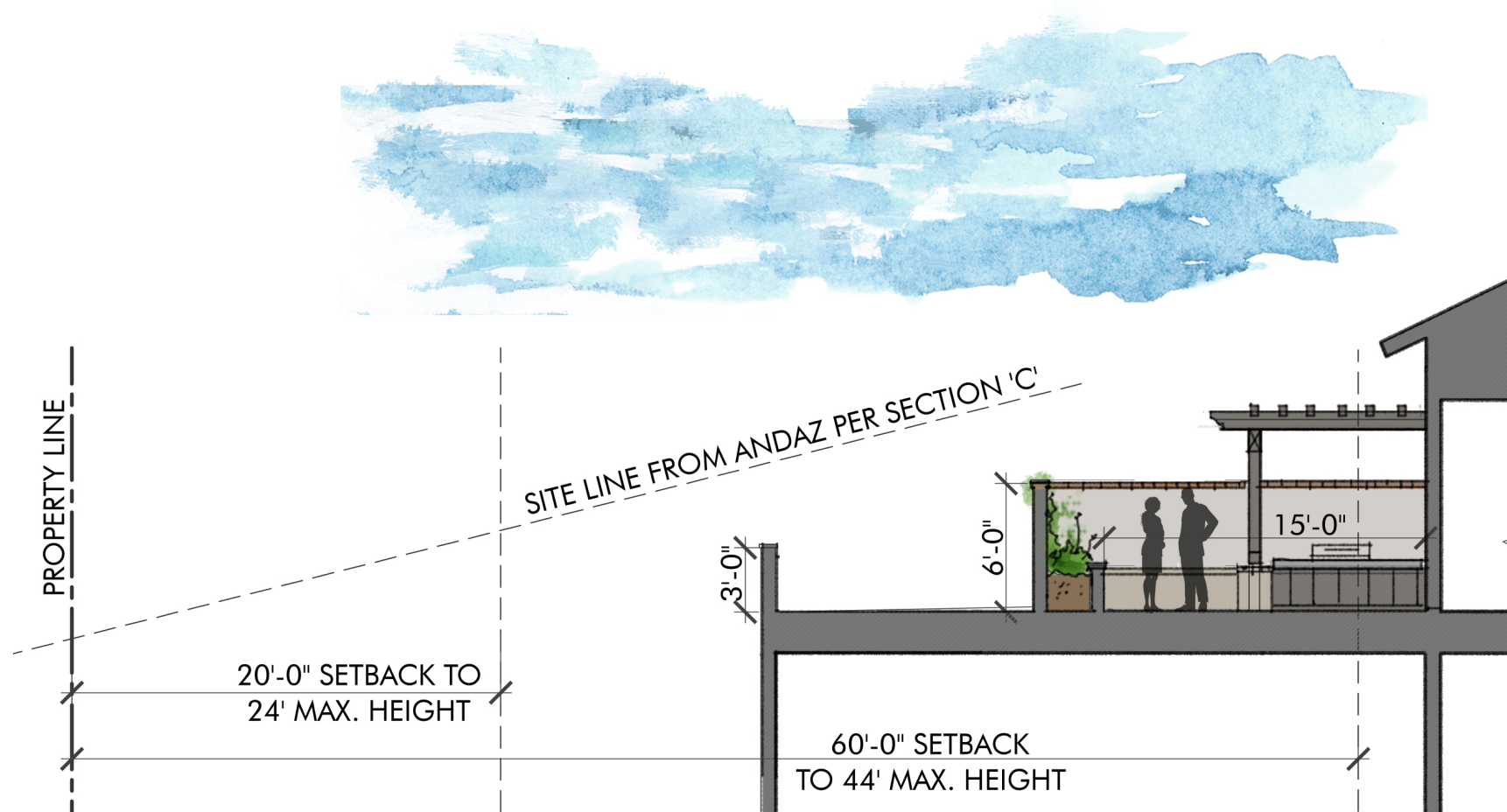

CONCEPTUAL SOUTH PATIO PLAN AND SECTION



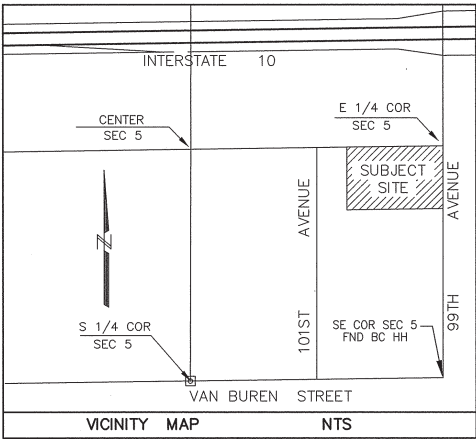
Patio plan and section is conceptual.

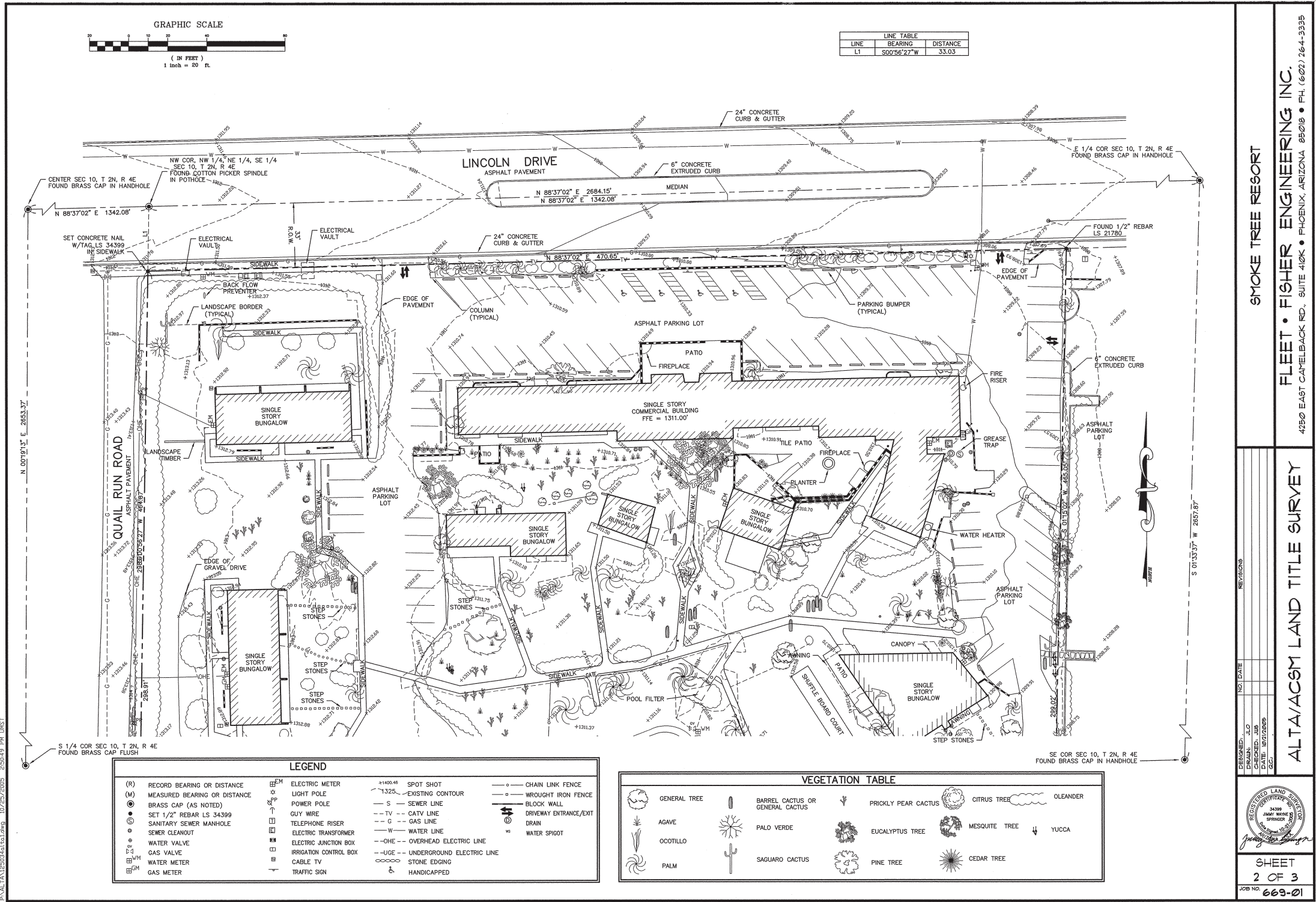

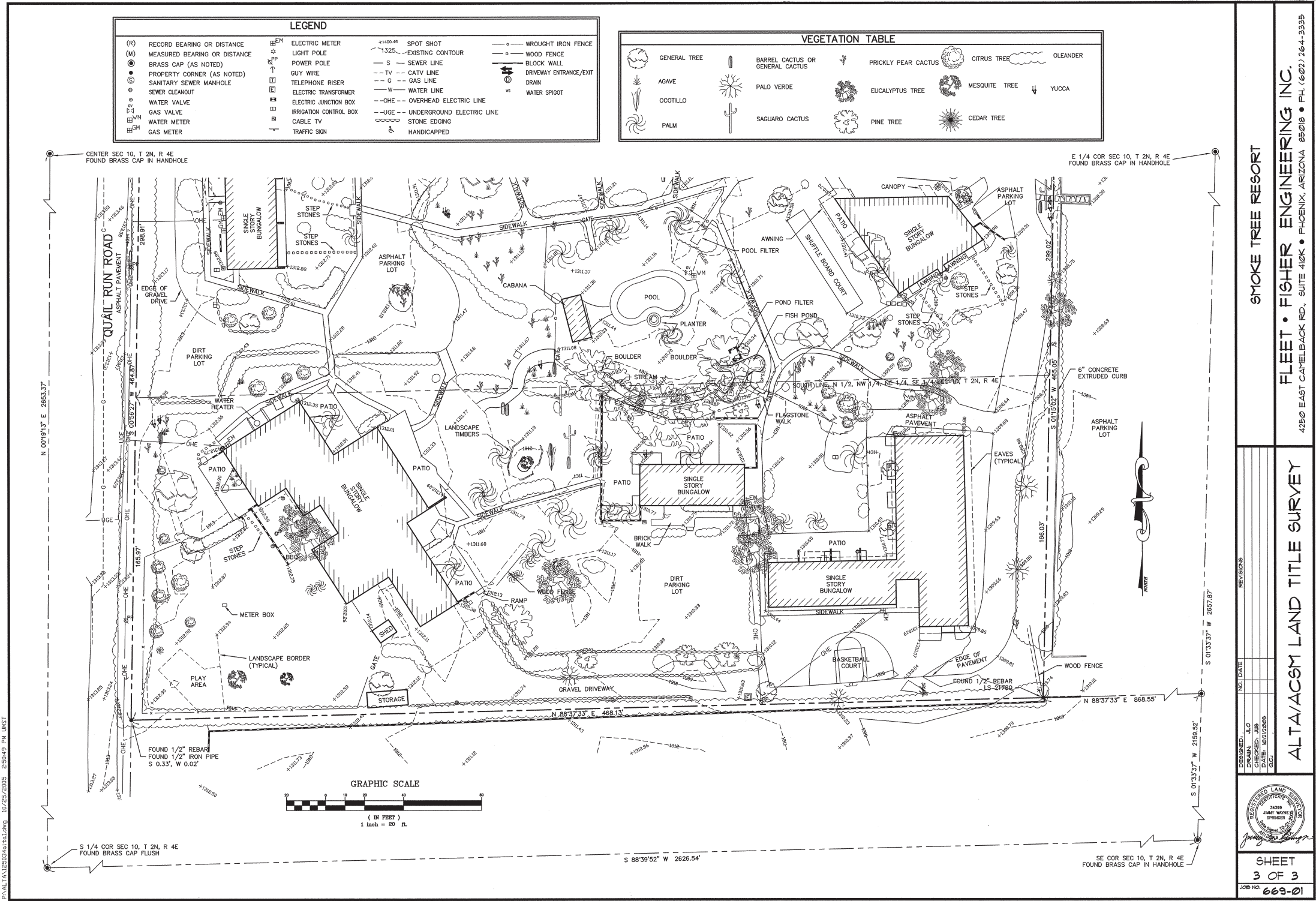
