Thank you. Scott tonn called to let me know the house is going to be beautiful, living deck is on lower part, so that is good. He said no one spoke about it at all

We may need to look at updating solar requirements since they really glare to houses above and putting a low level parapet wall does not solve the issue. So we should see if this needs to be tweaked on Hillside homes

We also need to consider the white roof issue for entire town. Scottsdale desert palette for homes in mountains area has a desert palette that blends in better than the bright white roofs. And it costs virtually nothing to add a light tan tint into foam going onto roofs with no real reduction in reflection. So it may be time to get this addressed on our retreat agenda to fix for entire town

Not sure if there are more items like this but these two would help reduce conflict in the town and make it more aesthetically pleasing

We also should consider whether to revisit the mediation program I previously had on retreat list to address drainage disputes between neighbors as there seems to be an increasing number of disputes especially when new construction starts. I talked to Andrew Miller about this earlier this week.

We need to be careful to put builders on notice about requirements of Solar on hillside and it is not generally approved. Many have been turned down for the exact reasons raised in this case by surrounding neighbors and owners. Thx for the consideration

Hi George,

I apologize, once construction started, I shift to several other project and am no longer involved in the day to day with the Mclinden Residence.

Unfortunately, no one told me about the addition of solar and Andy was unaware that hillside approval was required for the solar panels.

I will be submitting drawings ASAP for hillside review.

The solar that we are proposing will be located on the lower parapet roof of the garage/kitchen wing.

The panels will be mounted with minimal slope and will be fully screened in elevation with a +/- 13" parapet.

The mounts will be dark and the panels will also be the darker than the approved roof.

Please let me know what the hillside process for the addition of the solar.

I'm assuming this can not be done administratively and will need to go through the Combined review.

Please let me know if you need me to come in for a pre-app meeting.

I apologize again for the confusion.
