#### **CIP Scoring Criteria**

- High (Point Range: 7 to 10)
  - Protects health & safety of the Town
  - Federal, State, or contractual mandate
  - Leverage Federal, State, or other funding sources
  - Planned or ongoing project coordination of private or public improvements by others
  - Prevents irreparable damage to existing facilities
- ☐ Medium (Point Range: 4 to 6)
  - Results in increased efficiency
  - Maintains existing service levels
  - Preserves or enhances existing facilities
  - Reduces operational costs

- ☐ Low (Point Range: 1 to 3)
  - Provides an expanded level of service
  - Deferrable (funding availability, non-urgent)



#### **Proposed Additions**

Ten new projects are being proposed, in order of highest score as follows:

- 1) Miscellaneous Drainage Improvements (various locations), 9.0
- \*RWC Fiber Connection (Lincoln Dr) Phase I conduit only, 7.5
- 3) RWC Fiber Connection (Lincoln Dr) Phase II fiber, 7.5
- 4) License Plate Readers Update, 7.4
- 5) 56th St & Doubletree Ranch Rd Intersection Improvement, 7.4
- 6) \*Lincoln Dr Median Improvements: 32nd St to Tatum Blvd, 7.1
- 7) \*Lincoln Dr Median Improvements: Tatum Blvd to Mockingbird Ln, 7.1
- 8) \*Lincoln Dr & Tatum Blvd Improvement VSC, 6.0
- 9) McDonald Dr Curb Replacement: 40th St to 44th St, 5.0
- 10) Town Gateway Entry Features VSC, 4.1

\*Catalyst for the number of new projects on Lincoln Dr is due to the timing of the Town's mill and overlay project on Lincoln Dr currently scheduled for the summer of 2020. These projects, if approved, must be completed prior to the mill and overlay project.



#### **Proposed Deletions**

Eight projects being recommended for deletion from the CIP are:

Golf Dr Improvements, 2019, \$75,000

Doubletree Ranch Rd: Scottsdale Rd to Invergordon Rd, 2019, \$3,190,000

Town Hall Backup Power, 2022, \$200,000

Waterman Ln Improvements, 2022, \$300,000

Walk & Bike Improvements, 2020 to 2023 (annually), \$100,000

Mockingbird Ln: North of Hummingbird, 2021-2022, \$2,770,000

Invergordon Rd Medians: McDonald Dr to Chaparral Rd, 2020-2021, \$2,700,000

Mountain View Rd Improvements: Tatum Blvd to 52<sup>nd</sup> St, 2020-2021, \$1,100,000

Reason(s):

No longer a planned expenditure (contingency item); Camelback Golf Course is working on grading solutions and flood plain delineation

Deferrable; last overlay in 2008; project may be reconsidered prior to future mill and overlay in approximately 2028

Disaster recovery efforts have kept services operational

Public Works added asphalt layer to reduce roadway dip

Improvements are typically included in other capital projects; no need to create separate budget item; Walk & Bike Plan cancelled in 2018

Deferrable; pavement condition index is 85 as of February 2019; project may be reconsidered prior to future mill and overlay in approximately seven to ten years (year 2026 - 2029)

Deferrable; pavement condition index is 82 as of February 2019; project may be reconsidered prior to future mill and overlay in approximately six to nine years (year 2025 - 2028)

Deferrable; pavement condition index is 79 as of February 2019; project may be reconsidered prior to future mill and overlay in approximately five to seven years (year 2024 to 2026)






#### **SRP Denton Ln Underground Conversion**

Conversion of approximately 800 linear feet of overhead primary line in rear yard easements.

- New trench and conduit in town right-of-way
- Remove four power poles




#### **Sewer System Assessment**

Per IGA with Scottsdale, 20% of sewer system inspected annually.

- Identifies issues that need to be addressed such as roots, aging pipe, dips, offset joints, pipe material, etc.
- Completed first three years, two years remaining (FY20 & FY21)
- \$234,200 per year for five years totaling \$1,171,000





#### **Sewer System Improvements**

From sewer system assessment, repairs are made based on defect and potential risks to public health, and to town

- Annual allocation of sewer fund monies vary
- Increased expenditures in FY20 & FY21 due to sewer line structural deficiencies.


#### **Town Hall Optimization: IT Office Spaces & New Entry**

Based on a 2017 space study utilization of Town Hall, a remodel of the Community Room will include:

- Five IT office spaces
- Storage space
- New front entry
- New air handler
- Building safety enhancements



- May require street cuts in Lincoln Dr

#### RWC Fiber Connection (Lincoln Dr) - Phase II fiber

Install fiber for the Regional Wireless Cooperative (RWC) along Lincoln Dr to:

- Improve RWC communications
- Increase public safety communications reliability
- Provide "smart street" infrastructure

#### 56<sup>th</sup> St & Doubletree Ranch Rd Intersection Improvement

Install left and right turn lanes on 56<sup>th</sup> St at Doubletree Ranch Rd to:





- Work will be within Phoenix right-of-way, and IGA may be necessary
- Potential grant opportunity



#### **Tatum Blvd Retaining Walls**

Design and construct retaining walls adjacent to sidewalks

 Current cut face is eroding causing debris on the sidewalk

#### **Town Hall Chiller Replacement**

#### Replace chiller due to age

- Installed in 2002
- Average lifespan: 15 20 years
- Parts to maintain the equipment are difficult to find and more expensive
- Chiller provides cold water to Town Hall air handlers
- If it fails during summer months, it may require closure of Town Hall





- Work within Phoenix right-of-way and an IGA will be necessary
