2. ACTION ITEMS

- 19-312** Consideration of Ordinance 2019-09 Amending Section 2-5-2.I of the Town Code Modifying Alternative Design Standards for Small Wireless Facilities Located in Town Rights-of-Way

Community Development Director Jeremy Knapp presented Ordinance Number 2019-09 amending Section 2-5-2(I) of the Town Code. The amendment modifies the alternative design standards for Small Wireless Facilities located in the Town right-of-way. He stated that an applicant approached the Town with a request to replace two existing street light poles with two new street light poles and cellular equipment on top located on Scottsdale Road between Jackrabbit Rand and Vista Drive. The existing design standards would be inconsistent with surrounding landscaping and light poles. The ordinance change permits an alternative design for small cellular facilities on Scottsdale Rd to be consistent with the streetscape.
