The Town has adopted the 2015 International Fire Code which includes several chapters that deal with Compressed Gases, Cryogenic Fluids, Flammable Cryogenic Fluids and Oxidizing Cryogenic Fluids. Dear Ms. Knudsen:

Staff reviewed the application with the current Lincoln Dr. access locations but acknowledges that this may change as shared left in/left out access with the Smoke Tree Resort along the western property line is being pursued. A change in access location and configuration will result in addition comments. The comments below are based on the pre-application request submitted on October 11, 2019:

## • Parking/Traffic/Circulation:

- CivTech Parking memo dated October 28, 2018 shall also include an analysis
  utilizing the Institute of Traffic Engineers requirements for medical offices. This
  analysis shall also include the current approved uses of an Urgent Care and
  Pharmacy.
- All parking stalls shall meet current Town Code requirements of 180 ft<sup>2</sup> (minimum). Parking stalls shall be a minimum of 9' wide by 20' in length. Parking stall length may be reduced to 18' where 2' of overhang is available.
- Dive isles shall be a minimum of 24' in width for 2-way circulation.
- For Lincoln Dr. east and west entrances provide stacking for two vehicles (50') off of Lincoln Dr. prior to any parking stalls.
- <u>Drainage</u>. Provide narrative on existing storm water drainage patters and if proposed improvements will or will not be affected. If drainage is affected provide grading and drainage improvement plan to mitigate affects.

## • Other:

- Show Town's proposed Lincoln Dr. roadway improvements with existing driveway entrances and new sidewalk. Please provide the name and email of the appropriate person to send the CAD files to.
- The Town administratively approved an updated landscape plan in September 2019. Applicant shall coordinate installation of landscaping with the Town's Lincoln Dr. roadway, driveway and sidewalk improvements.

• Provide quit claim deed to the 33' of Lincoln Dr. from the monument line to the south in order to clean up public access to the site.

Paul,

Would you adding the following to the draft stipulations? I think it fits between c. and d.

A monitored alarm system should be fitted to provide a visual and auditory signal in the event of a deviation of pipeline pressure by more than +- 20% from the nominal distribution pressure. If an auditory signal can be silenced by the operator, the silencing shall not prevent the auditory signal from being activated by a new alarm condition. The alarm system should be tested periodically as recommended by the equipment manufacturer. The Master alarm shall be monitored 24 hours daily.

I am comfortable with the safety of the tank with this addition.
